MANAGER'S REPORT:

VILLAGE MANAGER REPORT FOR MONDAY, NOVEMBER 16, 2015

- 1. Installation of LED streetlights throughout the Village has begun early! Work crews started the project on Thursday, November 12th.
- 2. We are trying our best to keep everyone up to date on the Village's road improvement project, but it has been a challenge getting accurate schedules from the contractor. As we get updated information, road improvement progress has been posted on our website and through social media.

- 3. The contractor is working to finalize as much of the 9A project as possible before winter sets in, although the good weather we've been experiencing may allow them to get more work completed than originally planned. However, as of right now, we are not expected the final pavement to be done on 9A until the Spring so that we can coordinate work on the water main that United Water intends to run across 9A through Addyman Square! We don't want to have this work on 9A finished and then have the road ripped up again for the water main. There are a number of contractors and agencies involved in all of these activities, so we are working to coordinate as much as possible and minimize the traffic impacts. Con Ed has been working to relocate the gas main by Center St. and they are removing two utility poles in the 9A project area.
- 4. Con Ed has been continuing the storm hardening work by Village Hall, which has also contributed to a challenging road situation in the Village.
- 5. Village offices will be closed on November 26th and 27th for the Thanksgiving holiday. There will be no collection of recyclables on the 11th. Collection of <u>all</u> recyclables will be done on Thursday, November 12. Please refer to the Sanitation schedule posted on the Village's website.

TREASURER'S REPORT: Village Treasurer, Marion DeMaio read the Treasurer's Report:

Ms. DeMaio stated the bills for the past two weeks totaled as follows: General Fund: \$1,178,613.10; Trust & Agency Fund: \$944.97; and from the Capital Fund: \$66,627.42.

Resolved, that Chabad of the Rivertowns is permits to construct a Menorah display at or about Village property in Legion Park provided such a display and location is reviewed for safety and compliance by the Chief of Police, the Building Inspector, and the Fire Department, that all costs for the erection, use and maintenance of this display are borned by Chabad of the Rivertowns, and that a policy of insurance in acceptable form be provided to Ardsley to insure, indemnify, and defend against any and all claims or losses that may arise out of the erection, use, maintenance of this display. **Seconded by Trustee Malone and passed unanimously.**
