MANAGER'S REPORT 9/21/15

- 1. Project updates are being posted periodically for the 9A work so be sure to connect with us on Facebook, Twitter, and Constant Contact via our website.
- 2. The County received 9 bids for the Ashford Ave bridge on September 9. The review and approval is expected to take between six and 16 weeks. Any updates we receive will be posted on-line and through social media.
- 3. The work being done in front of Village Hall is being done by Con Edison. They are utilizing storm hardening funds to provide redundant electric service to Village Hall and the Firehouse in the event of an outage. We expect the vast majority of this work to be completed by early next week.
