FIRE REPORT:

Chief Mark Florkowski reported the following activities for December 2012:

Chief Florkowski stated that a smoke detector went off in a local jewelry store during a repair. He said there were 28 calls in December for smoke detectors going off, and gas odors due to cold weather.

8:00 P.M. – PRESENTATION – FINANCIAL STATEMENT FOR FISCAL YEAR ENDING 5/31/2012 - BY ALAN KASSAY – O'CONNOR, DAVIES, MUNNS & DOBBINS, LLP

Mr. Kassay reported that the financial statements for fiscal year ending 5/31/2012 had a clean opinion. He gave details on the opinion. He noted that it is the best opinion that can be received.

He stated that an Actuary must now calculate liability for current employees and retirees for post-employment benefits. There is an interest charge associated with this work. The General Fund is not affected. It also does not affect the budget process. He said in New York State this liability cannot be funded.

Mayor Porcino inquired about the change in terminology. Mr. Kassay discussed old and new terminology used by the Governmental Accounting Standards Board (GASB) and gave examples. He noted that no categories were changed.

Mr. Kassay stated that the Village has a 'AA' bond rating.

Mayor Porcino addressed the 2% Tax levy cap that the State mandated. Mr. Kassay said many municipalities throughout the State have over-ridden the cap. He said the 2% tax levy is expected to expire in 2016. Mayor Porcino stated the Board of Trustees passed the override at the last meeting.

Mr. Kassay said the budget was well prepared in terms of revenues, and was conservative. He noted that there is control over the area of appropriations. Mr. Kassay mentioned that Village Collections were very good.

Ms. Demaio left the meeting at 8:34 p.m.

MANAGER'S REPORT:

VILLAGE MANAGER REPORT FOR TUESDAY, JANUARY 22, 2013 PREPARED BY GEORGE F. CALVI

<u>SIDEWALK PROJECT</u>: Later this evening the Village Board is expected to approve a resolution authorizing the Village Clerk to advertise a Notice to Bidders for the Safe Routes to School project. This is the half million dollar federal grant administered through the State of New York that will create brand new sidewalks for us on the north side of Heatherdell Road between Farm Road and Olympic Lane. In addition to sending notices to a compiled prospective bidders list, we will be advertising in The Journal News and The NYS Contract Reporter. There will be a highly recommended pre-bid meeting on February 8, and the sealed bid opening will be on March 1. To date, those are the only dates carved in stone. Owing to the vagaries of NYS DOT's option to review the bids over 60 days, and the utility companies option to relocate the telephone poles also over 60 days, we estimate the actual construction will commence in late May, early June, with an outside completion date of August 1. Incidentally, the bid packet is available for a non-refundable fee of \$35.00.

SCHOOL TAX: Village residents are reminded that the second installment of the School tax is due on Thursday, January 31. For those of you who like to pay in person at the last minute, please remember not to bring your payments to Ardsley Village Hall. Bring them directly to Greenburgh Town Hall which is located at 177 Hillside Avenue across the street from Dannon Yogurt. Mayor Porcino inquired about VHB, and the parking structure status. Mr. Calvi said David Smith has scaled down the proposal by \$5,000. Mr. Calvi noted that the State was looking for an indication as to whether there would be issues with the parking structure behind Colonial Court. Mr. Calvi stated that per David Smith there were no issues. Mr. Smith was authorized to go forward with the work.

Mr. Calvi welcomed and recognized Don Marra who, he said, has worked diligently over the past five years on the sidewalk project. He has reviewed all of the paperwork. Mayor Porcino also thanked Mr. Marra for his efforts.

TREASURER'S REPORT: Mr. Calvi read the Treasurer's Report on behalf of Marion Demaio.

Mr. Calvi stated that the Trust & Agency Fund was reduced by \$36,000 (removal of contribution to Fireman's Service Award Fund).

The bills totaled as follows: General Fund: \$180,528.55; Trust & Agency Fund: \$8,443.20; and Capital Fund: \$154.80.

Trustee Nardecchia: Resolved, that the Village Board of the Village of Ardsley hereby authorizes the Village Treasurer to make the following payments: From the General Fund: \$180,528.55; Trust & Agency Fund: \$8,443.20; and from the Capital Fund: \$154.80. **Seconded by Trustee Malone and passed unanimously.**

BUILDING INSPECTOR'S REPORT:

Trustee Kaboolian reported for the month of December, 2012 that the number of fees, permits, Certificates of Occupancy (CO), and Letters of Compliance were 42, for a total of \$16,785.00. There were 90 inspections.

BE IT RESOLVED, that the Village Board of the Village of Ardsley hereby adopts a resolution authorizing a Notice to Bidders for the construction of new sidewalks on the north side of Heatherdell Road between Farm Road and Olympic Lane funded by the federal Safe Routes to School program. **Seconded by Trustee Nardecchia and passed unanimously.**

Consultant and former Dobbs Ferry Mayor Donald Marra addressed the moving of poles. He stated that Con Edison and Verizon will not move their poles until a bid is awarded and a contract is signed. He said the awarded bid has to be sent to the Department of Transportation (DOT). The DOT projected a completion date of August 1, 2013.
