I. PLEDGE OF ALLEGIANCE

Mayor Porcino noted the presence of two guests in the audience this evening: County Legislator Mary Jane Shimsky, and Commissioner Jay Pisco, from the Department of Public Works and Transportation.

Mayor Porcino presented a plaque to Village Justice Walter Schwartz, in recognition for 35 years of service to the Village. County Legislator Mary Jane Shimsky also presented Justice Schwartz with a plaque commemorating his 35 years of service.

Mayor Porcino introduced Jay Pisco, newly installed Commissioner of Transportation and Public Works and Scott Donnelly, Traffic Director & Engineer to discuss the status of the Ashford Avenue bridge.

Mr. Pisco explained that, currently, interim repairs are taking place on the project. Planking was recently installed to prevent any falling debris and will be left in place for future repairs. Repair work is taking place on the steel work as well. Since both State and Federal funding is involved with the project, many procedural steps must be followed which will affect the scheduling of the work.

The design is taking place from now until August, 2014. Bids for the reconstruction of the bridge will be let November, 2014. Construction is expected to be completed by February, 2017.

Mr. Donnelly explained that there are approximately 36 major steps in this project. The Design Approval Document is currently being voted on. Next month, a public meeting will be scheduled to discuss the project, obtain input from the public, finalize the Design Approval Document and submit it the following month (mid May) to the NYS DOT. The Design Approval Document typically goes back and forth two-to three times prior to approval. Once approval is obtained, the final design will be sought.

Once awarded, the plans and design will be made available to the general public via a link to the county's website.

Temporary construction easements will be required 50 feet on both sides of the bridge on Elm Street. Mr. Calvi requested the Highway Department be given as much lead time as possible when temporary construction is about to begin. An advertisement date for the work is being sought for November, 2014, with a construction start date of approximately March, 2015.

Currently, funding is locked in place but is unavailable until 2014.

In order to cut down on construction time, the deck of the bridge will be cast off-site using ultra-high strength concrete with the steel. The placing of the cranes will need to be finalized, however, the project will take place in two phases.

Upon commencement of construction, there will only be two lanes of traffic open and when the south side of the bridge is closed, during phase one, the ramp to the SMR Parkway will also be closed and demolished. A detour down Ogden Avenue will allow for access to the parkway.

When work commences on the north side, the ramp will be reopened, however, since there will only be single lane traffic for both east and westbound motorists, no access (left turns) will be allowed on to the ramp. Motorists intending to travel north on the Saw Mill Parkway will be diverted to Lawrence Street.

A public hearing will take place on the design and plans in about a month's time in either Dobbs Ferry or Ardsley.

Monitoring of the condition (or deterioration) of the bridge will continue from now until November, 2014.

8:30 P.M. – CONTINUATION OF PUBLIC HEARING – To consider a request to convert the existing vacant office/retail space into two residential dwelling units located at 609 Saw Mill River Road, Ardsley, New York.

Mayor Porcino read the legal notice.

Mr. Ed Marron, Jr., engineer, representing Mr. Bobolakis, owner of the property, explained that they had previously been to the Zoning Board of Appeals and been granted a variance to convert a first floor office space to residential space. The request for residential entails a one bedroom and a two bedroom unit on the first floor.

Mr. Tomasso, Building Inspector, explained the difficulty which Mr. Bobolakis has had in trying to rent the property for commercial usage.

Mr. Marron explained the reasoning behind the use variance approval by the Zoning Board of Appeals.

- First, the Zoning code, due to the parking issue, does not allow any uses on the first floor which comply with the ordinance.
- Secondly, a hardship case was proven by Mr. Bobolakis.

Mr. Tomasso explained that the changes proposed to the exterior of the property are minor and, therefore, they have not yet gone before the BAR but will do so if the application is approved this evening.

Mayor Porcino left the application open for public comment.

Tr. Levine: Resolved, that the Village Board of the Village of Ardsley hereby closes the public hearing to consider a request to convert the vacant office/retail space into two residential dwellings, located at 609 Saw Mill River Road, Ardsley, New York. **Seconded by Tr. Malone and passed unanimously.**
