VILLAGE MANAGER REPORT PREPARED BY GEORGE F. CALVI FOR WEDNESDAY, APRIL 20, 2011

1. **GARDEN CLUB EVENT:** On behalf of Trustee Beverly Levine and President Mary Keehan, I am announcing tonight that the Ardsley Garden Club will be holding its annual flower show on Wednesday, May 4, 2011 from 2:30 pm to 8:00 pm at Saint Barnabas' Episcopal Church located at the corner of Revolutionary and Heatherdell Roads. This year's theme is "Poetry and Flowers." Admission is free and all are invited to attend!

2. **GOOD FRIDAY**: Village offices, along with DPW, will be closed on April 22 in observance of Good Friday. This means that trash collection will be conducted throughout the entire village on Thursday, April 21. If by chance you miss Thursday's collection, please do not leave it curbside so that your neighbors have to stare at it all weekend long. Thank you in advance for your consideration. VI. VISITORS

Mr. Michael Kolesar, 35 Park Avenue, Ardsley, presented himself to the Board to further discuss the Village budget as was begun at the last meeting.

The issue of serial bonds was discussed and Mayor Leon explained that this was being considered, however, the library reconstruction will not be included in this proposed budget change.

Mr. Kolesar spoke regarding unresolved parking tickets in the Town of Greenburgh and the upcoming water rate increases.

Mr. Kolesar expressed concern regarding the financial matter of the Water Wheel project.

Ms. Patricia Hoffman, 69 Bramblebrook Road, Ardsley, presented herself to the Board regarding the Ridge Hill project. A brief background was given regarding the \$5M for road improvements. Ardsley is earmarked to receive approximately \$2M for road improvements.

Ms. Hoffman expressed concern regarding the progress and development of the projects. One major question is the time element involved since the money needs to be used by August, 2014. Ms. Hoffman requested a schedule of submissions dates and target deadlines for completion of the projects.

Tr. Porcino responded that an informal timeline exists but he would request something in writing.

Ms. Hoffman referred to the February 1st meeting whereby the residents were invited to attend and the issue of the takings was addressed. Ms. Hoffman requested if the taking projects have moved forward.

Tr. Porcino and Mr. Calvi did not have any information regarding the takings.

BOARD OF TRUSTEES APRIL 20, 2011

Mayor Leon reminded them that State Assemblyman Tom Abinanti was to have followed up with them. Attorney Ponzini stated that he contacted Mr. Calvi regarding this situation and Mr. Calvi responded that there was a imminent meeting upcoming and he would advise Atty. Ponzini thereafter. Mayor Leon requested Mr. Calvi follow up every day until the project was moved forward. Mr. Calvi advised that if he was being charged with the task, he would accept handling it.

Attorney Ponzini suggested dealing directly with the property owners.

Mayor Leon stated that public hearings for the takings will be required which Mr. Calvi with the assistance of the Village Attorney will finesse.

Ms. Hoffman urged the Board to expedite the process and not jeopardize the \$2 million from the Ridge Hill settlement.

VII. MAYOR AND BOARD REPORTS

MAYORS ANNOUNCEMENTS:

- 1) The Little League Parade took place on April 9, 2011.
- The last two budget meetings are scheduled for April 25 and, tentatively, April 27.
- 3) Village resident Will Gonzalez will become an Eagle Scout on April 30. The ceremony will take place at the Community Center.
- 4) The MTA tax is budgeted at \$18,000 this year, up 13% from the proposal of two years ago. Hydrant rentals are up to \$108,715, up 19% over this year's projection. The State retirement is \$810,000, up 72% from 2010-2011, not including the library employees. These items are all mandated by the State legislature. The hydrant rentals were approved by the Public Service Commission, which is a State commission.
- 5) Happy Passover and Happy Easter was wished to all.

RESOLUTION REGARDING ATTENDANCE OF POLICE SERGEANT AT INTEGRATED JUSTICE PORTAL SEMINAR IN ALBANY

Trustee Malone: Resolved, that the Village Board of the Village of Ardsley hereby authorizes Police Sergeant Evan Kanigher, at the recommendation of the Police Chief, to attend training for the new unified "eJusticeNY Integrated Justice Portal" (IJAB) sponsored by the Integrated Justice Advisory Board, the NYS Department of Corrections, the Division of Criminal Justice Services, the State Police, the Division of Parole, and Homeland Security and Emergency Services in Albany from May 16 through May 18 at an amount not to exceed \$350.00 to cover meals and lodging [two nights @\$104 + \$142 meals & incidentals]. Sgt, Kanigher will be provided a patrol car for transportation, and there is no cost for registration or training. Seconded by Trustee Levine and passed unanimously.

RESOLUTION AUTHORIZING EXECUTION OF 2011-2015 STOP DWI IMA

Trustee Porcino: Whereas, in January 2007 the Village Board authorized the Village Manager to sign a four year agreement with the County of Westchester for the provision of a STOP DWI PATROL PROJECT REIMBURSEMENT AGREEMENT, and that agreement expired on December 31, 2010

Be it resolved, that the Village Board of the Village of Ardsley hereby authorizes the Village Manager to execute a five year inter-municipal agreement with the County of Westchester for the provision of a STOP DWI PATROL PROJECT REIMBURSEMENT AGREEMENT for the period January 1, 2011 through December 31, 2015 for an amount not to exceed \$8400 annually. Seconded by Trustee Malone and passed unanimously.

Trustee Malone: Resolved that the Village Board of the Village of Ardsley hereby authorizes the Village Treasurer to modify the 2010-2011 Village Budget by increasing revenue line item A3989 by \$5,980 to reflect the anticipated receipt, and increasing appropriation line item 3120.210 by \$5,980 to reflect a grant awarded by the NYS Governor's Traffic Safety Committee to participate in the "Buckle Up New York!" campaign. **Seconded by Trustee Porcino and passed unanimously.**

RESOLUTION MODIFYING 2010-2011 VILLAGE BUDGET – "CHILD PASSENGER SAFETY" PROGRAM

Trustee Malone: Resolved, that the Village Board of the Village of Ardsley hereby authorizes the Village Treasurer to modify the 2010-2011 Village budget by increasing revenue line item 3120.210 by \$4,500 and appropriations line item A3989 by \$4,500 to reflect the anticipated receipt and expenditure for funds from a grant awarded by the NYS Governor's Traffic Safety Committee to participate in the "Child Passenger" program. **Seconded by Trustee Porcino and passed unanimously.**

RESOLUTION REGARDING SERVICE AWARD PROGRAM – VANGUARD TRANSFER OF FUNDS

Trustee Porcino: Resolved, that the Village Board of the Village of Ardsley hereby authorizes the Village Manager to transfer \$75,000 from the Vanguard US Treasury Fund into the Vanguard Small Cap Growth Index Fund (Symbol: VISGX) for the Village's

Volunteer Fire Fighter Length of Service Award Program also known as LOSAP. Seconded by Trustee Malone and passed unanimously.

RESOLUTION ACCEPTING RESIGNATION OF PATROLMAN MICHAEL PETRUOLO

Resolved, that the Village Board of the Village of Ardsley hereby accepts, with regret, the resignation of Patrolman Second Grade Michael Petruolo for the purpose of transferring to the Westchester County Department of Public Safety, effective midnight April 17, 2011

RESOLUTION CONSIDERING REQUEST TO ERECT TEMPORARY SIGNS FOR MEMORIAL DAY

Trustee Malone: RESOLVED, that the Village Board of the Village of Ardsley hereby approves a request from Ardsley American Legion Post 458 to erect two 4' x 8' signs with information regarding the Memorial Day ceremony and parade; one sign to be placed at the southwest corner of the intersection of Route 9A and Ashford Avenue, and the other to be placed at the jug-handle corner of Ashford Avenue and McCormick Drive, as in prior years. The signs will be erected approximately May 18th and will be removed on May 31, or June 1st. **Seconded by Trustee Porcino and passed unanimously.**
