- 1. TAX BILLS DUE: The second installment of the Village tax bill, mailed to all property owners in early June, is due by the end of the business day on Tuesday, January 3, 2012. Mailed payments postmarked Wednesday, January 4, 2012 and beyond, and payments made in person on January 4 and beyond at Village Hall will be assessed a penalty as prescribed by New York State law. No one can waive the penalty. Bear in mind only a bona fide U.S.P.S. postmark evidences timeliness. Should you have any questions, please telephone Village Treasurer Marion DeMaio, or Dipika Patel at 693-1550 during regular business hours.
- **2. PERSONNEL**: In accordance with the civil service rules and regulations of the Westchester County Department of Human Resources, the following is hereby entered into the official minutes:

## POLICE DEPARTMENT REPORT:

Chief Coulehan delivered the police report for the month of November. The issue of the traffic on Ashford Avenue heading toward Dobbs Ferry was discussed. Chief Coulehan advised the Board that he would look into having the traffic lights adjusted.

**8:30 P.M.** – **PUBLIC HEARING** – For the purpose of modifying an existing site plan for Ardsley Snack Mart located at 730 Saw Mill River Road, Ardsley, New York.

Mayor Porcino read the legal notice.

Mr. Tony Martelli, Maintenance Manager, Philco Smart Foods, presented himself to the Board and explained that the Shell Station on Saw Mill River Road is one of his locations. Approval is being sought for an 8' x 8' storage shed next to the building. Due to the slope of the land, the shed will not be totally concealed from view.

Mr. Martelli handed pictures to the Board of the proposed shed and its proposed location. The color and design match the existing building. The shed would be used for storing window washer fluid in the winter and soda, etc. in the summer months.

Mayor Porcino questioned where these items were currently being stored. Mr. Martelli stated they were cramped into a back room.

Tr. Nardecchia questioned why an addition to the building is not being considered. Mr. Martelli responded that he is new to the company and does not know the answer to that question.

Tr. Nardecchia explained that all other approved sheds in the Village are out of view from the street.

Mayor Porcino mentioned that two previous applications had been approved and were not visible from the street. Also, the sheds are not intended to be permanent solutions to storage issues. Mayor Porcino also suggested an addition be added to the building. Mr. Martelli stated the structure would not be permanently planted on the ground and would be movable, if necessary. He also stated that there were be cost restraints involved with adding an addition to the building but mentioned that he would take the suggestion back to his superiors.

Tr. Nardecchia also mentioned that accessory units were supposed to be related to the primary function of the business, which in this instance, is gasoline.

Mayor Porcino expressed his concern that this project should have been more adequately planned to meet the storage needs.

Tr. Levine stated that food products were not to be stored in the shed and that soda is a food product.

Tr. Nardecchia suggested locating the shed below ground and approaching it from the parking structure. Mr. Calvi mentioned that the parking structure was DOT property, which may pose a problem.

Mayor Porcino explained that if the permit was issued, it could be revoked at any time by the Village, with 30 - 60 days' notice.

The Board suggested the application be adjourned for two weeks and the applicant return at that time.

**Tr. Minore: Resolved,** that the Village of Ardsley hereby adjourns the public hearing and request from Food Mart with regard to the request by Ardsley Food Mart to modify the existing site plan and place a storage shed in the parking lot, until the January 3, 2012 meeting at 8:15 p.m. **Seconded by Tr. Levine and passed unanimously.**

**WHEREAS**, the Board of Trustees has referred this application to the Planning Board for review and comment; and

**WHEREAS**, in accordance with the provisions of section 167-3 D of the Village Code, the Board of Trustees must hold a public hearing on the site plan application.

**NOW THEREFORE BE IT RESOLVED,** that the Village of Ardsley Board of Trustees hereby schedules a public hearing for the Parasol Development site plan to be held January 17, 2012 at 8:45 pm in the court room at Ardsley Village Hall, 507 Ashford Avenue, Ardsley, NY 10502

## **BOND RESOLUTION DATED DECEMBER 19, 2011.**

A RESOLUTION AMENDING THE BOND RESOLUTION DATED OCTOBER 4, 2010, AUTHORIZING THE ISSUANCE OF \$185,000 SERIAL BONDS OF THE VILLAGE OF ARDSLEY, WESTCHESTER COUNTY, NEW YORK, TO PAY THE COST OF THE PURCHASE OF A GARBAGE TRUCK FOR SAID VILLAGE.

**Trustee Levine: WHEREAS,** all conditions precedent to the financing of the capital project hereinafter described, including compliance with the provisions of the State Environmental Quality Review Act (as a Type II Action), have been performed; and

WHEREAS, by a Bond Resolution dated October 4, 2010, the Board of Trustees of the Village of Ardsley, Westchester County, New York, authorized the issuance of \$185,000 serial bonds of said Village to pay the cost of the purchase of a garbage truck, including apparatus and incidental expenses in connection therewith, and determined that the period of probable usefulness thereof is fifteen years however, said period of probable usefulness was limited to five years therein; and

**WHEREAS,** it has now been determined that it is in the financial interest of said Village to amortize such serial bonds over a period in excess of five years, the period of probable usefulness of said specific object or purpose being fifteen years in accordance with the applicable provision of the Local Finance Law; and

**WHEREAS,** it is now desired to amend such bond resolution dated October 4, 2010 accordingly;

**NOW, THEREFORE, BE IT RESOLVED,** by the Board of Trustees of the Village of Ardsley, Westchester County, New York, as follows:

**Section 1.** Section 3 of bond resolution dated October 4, 2010, more fully described in the preambles hereof, is hereby amended to read as follows:

"Section 3. It is hereby determined that the period of probable usefulness of the aforesaid specific object or purpose is fifteen years, pursuant to subdivision 28 of paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized will exceed five years"

**Section 2.** The validity of such bonds and bond anticipation notes may be contested only if:

- 1) Such obligations are authorized for an object or purpose for which said Village is not authorized to expend money, or
- 2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or
  - 2) Such obligations are authorized in violation of the provisions of the Constitution.

3)

<u>Section 3.</u> Upon this resolution taking effect, the bond resolution of October 4, 2010, as herein amended, or a summary thereof, shall be published in full in the official newspaper of said Village for such purpose, together with a notice of the Village Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.

<u>Section 4.</u> THIS RESOLUTION IS ADOPTED SUBJECT TO PERMISSIVE REFERENDUM.
