Rivertowns Square: The Village Board is concerned about the Rivertowns Square project at Lawrence Street in Dobbs Ferry if built as proposed. The impacts on traffic, pollution, flooding, storm water, reduced green cover and potential harm to Ardslev businesses need more serious examination than has been provided to date. The Dobbs Ferry Board approved the environmental report in January, and the law requires us to file a court challenge within four months. While I have reached out to the developer to try to reduce the scope of the project and look for other ways to reduce the impacts on Ardsley -- and those discussions continue -- we nevertheless believe it was necessary to file the court challenge to preserve the Village's options. We will provide further updates as the situation develops.

Nixle Sign-Up: We have installed an emergency phone alert system (called Nixle) to notify residents of emergencies, storm related information, and cancellations of services. Your main phone number should already be in the system, but you can re-enter it to be sure. You can add mobile numbers and second phone lines. DOROTHY KAUFMAN RECOGNIZED

I had the pleasure of reading in the March 22nd Rivertowns Enterprise about my old friend Dorothy Kaufman who has lived in this community nearly 60 vears. Recently, she was honored at "Girl Scout Sunday" celebrated at the Ardsley Methodist Church on the occasion of the 101st anniversary of the Girl Scouts. A decades long scout and participant in Girl Scouting, Dorothy has been for many years a member of the Cable Ardslev Television committee, and did a brief stint as Chairwoman a few years ago. She also performed some part-time clerical work for us here in the

Village offices. However, my first involvement with Dorothy was back in 1990 when she and Louise Giusti, who were operating a recycling depot in the back parking lot of the old Village Hall, wanted recycling beyond to extend newspapers and to include curbside plastic and metal containers as well. Well, along with the assistance of then Trustees Linda Polhman and Dan Kelly, as well as Theresa DeStefano, not only did we secure a grant for the purchase of the first green recycling bins for village-wide collection, but we also devised the multi-colored Sanitation first schedule which was launched in the spring of 1991. Though she has been very active over the years with many civic organizations, I want to particularly note that she is our only known surviving WAVE from World War II. STORMWATER UPDATE: "ISLANDS IN THE STREET"

Traffic Islands – you see them all over the Village. Some have lovely annual flowers, courtesy of the Ardsley Garden Club, others have flowers provided by our Highway Department, and still others may just be paved over with asphalt. The Ardsley Environmental Task Force (ETF. formerly EAC, Environmental Advisory Committee), came up with a great idea to use the traffic islands as model sustainable native gardens. These gardens have low maintenance plants which require little watering and landscape The first one to be additives. planted is one of the Heatherdell Road islands. Thank you to the Highway Department for building up the Belgian block border and adding extra soil. Design and planting is part of Francine Klarsfeld's Girl Scout Gold Award project. There are perennial plants and colorful annuals grown from seed by Fran's Girl Scout Troop. Sustainable gardens (SG's) are "storm water friendly" because they spare water, don't add chemicals to runoff, and provide areas for street runoff to infiltrate back into the ground. If successful, more SG's are planned for other "islands in the street".

And while we are talking about Scouts, thank you very much to the Scouts for their annual Village Cleanup which took place on Saturday March 23rd. They always do a great job, and cleaning up helps keep trash out of our water, too.

GETTING TO KNOW THE SOCIAL HOST LAW

Do you know what the Social Host Law is? If not, you're not alone... this relatively new law is not well known, but can have significant ramifications. Passed in 2008 in Westchester County, the Social Host Law states that it is a violation for adults (21 and over) to allow underage drinking in their home or on their property. The primary purpose of the Social Host Law is to address the problem of adults who allow minors to drink alcohol homes, in their distinguishing this behavior from existing laws that penalize adults who actually provide alcohol. (Note: Under the Penal Law, parents are exempt from prosecution for providing alcohol to their own child in their own home, the same applies for the Social Host Law.)

The focus of the Social Host Law is to make parents who host underage parties realize the need for diligence against allowing underage drinking in their home and on their property. You can be charged with the Westchester County Social Host Law if you are 21 years of age or older, you own, rent or otherwise control the private residence. vou have knowledge that one or more minors are consuming alcoholic beverages in your home and you allow it OR you fail to take corrective action. The Penalties for breaking this law are as follows: 1st offense - \$250.00 fine; 2nd offense \$500.00; 3rd offense 1,000.00 and / or up to one year in jail. This law can be enforced by any municipality in Westchester County and prosecuted in any town, village or city. DOG LICENSES ARE NOT OPTIONAL

New York State Law requires that every person owning a dog must obtain a license if the dog is 4 months old or older. Licenses may be obtained either by visiting the Greenburgh Town Clerk's Office located at 177 Hillside Avenue in Greenburgh, or downloading a form from the Town's website, <u>www.greenburghny.com</u>. The fees range from \$16 to \$23. You will need to present a current rabies certificate at the time of registering your dog. Moreover, if you notice your neighbor is holding a garden party in the backyard or enjoying a little tranquility on their deck, maybe that's not the best time to turn on the leaf blower or the hedge trimmers or the buzz saw. the County of Westchester, the Town of Greenburgh, and a New Jersey firm, will facilitate the construction of 22 units on the former restaurant site.

Seventeen units will be affordable. and will help the County of Westchester in meeting its goals in connection with the federal housing settlement. The remaining five units will be set aside and classified as workforce housing, and will be allotted first to local first responders, specifically, fighters volunteer fire and volunteer ambulance workers.

Although all the land use approvals are in place, no date has been determined yet when the actual construction will begin, nor has an arrangement been made as to the procedure for securing one of the work force housing units.

The procedure for securing one of the affordable housing units will be spearheaded by the County of Westchester on a regional basis according to the terms of the federal settlement.

As for the split of the proceeds from the sale of the property, the formula includes making the Town and the Village whole for back taxes going back to 1994, a covering of out of pocket foreclosure related expenses, and an equitable split of the balance of the proceeds between the Village and the Town. – George Calvi, VM U.S. POSTAGE PAID WHITE PLAINS, NY PERMIT NO. <u>2026</u>

MORE ABOUT TREES

We last reported on trees back in the March issue. Two points though are worth repeating. 1) The Village urges you not to plant trees directly under power lines. Though holding curb appeal, bear in mind that today's dream tree can grow into tomorrow's nightmare. 2) The Village cannot become embroiled in disputes between neighbors on private property over trees. This is a civil matter. Whether it be a dead tree, a fallen tree, a tree threatening to fall, or overhanging branches, the resolution must be negotiated between the two parties. The Village plays no role whatsoever. I hope you find this information useful.
