We are saddened, however, to hear that the Village of Dobbs Ferry has just reduced the number of parking permits at its train station for non-residents from 100 to 75. Please be assured that your Village government will do all that it can to address this situation which is so vital to so many our commuting Village residents.

In the interim, all commuters are advised that there is a bus, the #66 which traverses Ashford Avenue from the Dobbs Ferry train station to the Scarsdale train station. In addition, there is the #39 bus which traverses Abington Avenue, Ashford Avenue, Addyman Square, Heatherdell Road, and on to the Hartsdale train station. Efforts are already being made to petition the County to extend the number of trips daily on each route.

Senior Housing Update

In January the Village Board adopted the scoping document for a Senior Assisted Living Facility on the 12 acre Pintel property which is bounded by Concord Road, the Ardsley Mall, Route 9A, and Sylvia Avenue. This document outlines all the issues that must be addressed as part of the environmental review process which will take place over the next three to six months. Your Village Board will closely monitor this proposal, especially as it concerns traffic and other environmental issues. The senior housing proposal calls for a total of 250 units, consisting of independent living units, assisted living units, and special care units - many of which are single room occupancy. Also included in the proposal are the construction of eighteen single family homes - four on Concord Road and the remainder on a cul de sac accessed from Sylvia Avenue. Sunny Texaco To Redesign

In January, the Village Board of Trustees approved the site plan for the refurbishing of the Sunny Texaco service station next door to the Village Green. Plans call for the demolition of the present building, the construction of a mini food mart, the installation of more and better configured fuel pumps, the erection of a canopy, and appropriate landscaping. The project should commence during the summer of 1999, and be completed by the fall.

Village Hall Dedication February 27

With the relocation of the Village Justice Court in late December, the move into the new Village Hall is complete. A dedication ceremony for the building has been scheduled for 10:00 am, Saturday, February 27. McDowell Park Parking Lot and Field Work In Progress

On February 1, the Village Board of Trustees awarded a \$67,000 bid for improvements to the McDowell Park parking lot to Etre Associates (ELQ) of Mamaroneck. The project design, a combined effort of DPW Foreman Lou Pascone, Little League Pres. Mike McHugh, and Consulting Engineer Larry Nardecchia, calls for new asphalt for the parking lot and basketball court, a reconfiguration of the parking spaces, new basketball backboards and posts, and the planting of some trees. This work combined with the drainage work donated by nearby Arrowcrest Properties, and the extensive field and fence work conducted by the Little League Association will forge McDowell Park into a jewel of the Ardsley Village park system. All work is planned to be completed before Little League's April Opening Day. The Village's portion of the project will be financed through a \$15,000 grant from Senator Spano's office, a portion of the Parks Reserve Fund, and monies from the current General Fund.

New Fire Pumper Displayed

In December, Fire Chief Ron Gretczko took delivery of a new Class "A" 1750 GPM Pumper Fire Apparatus from Saulsbury Fire Equipment Corp. of Tully, New York. The new vehicle was formally placed into service at a "wet-down" at the Fire House sponsored by the Ardsley Fire Department on February 7.

Pocost Park Taking Shape

Thanks to the efforts of many people Michael Pocost Memorial Park is taking beautiful shape. The pocket park located at the corner of Ashford Avenue and American Legion Drive was designed by Trustee Stephen Dalton and Barbara Novich, our Beautification Chairwoman. Funds for the three black steel benches were donated by the Duke Family of Dellwood Lane, the Sommerfield Family of Orlando Avenue, the DeMaio Family of Almena Avenue, and the Miano Family of Stonegate. The red inscribed bricks were donated by scores of Village residents. Electric conduit work for the installation of future light fixtures was donated by Robert Saltsman. The three half whisky barrels, which will be brimming with flowers in the Spring, were donated by the Ardsley Garden Club. The remainder of the work - regrading, seeding, laying of the brick work, and the erection of the split rail fence was a collaborative effort of Colonial Landscaping, Gun Hill Fencing, and the Ardsley DPW. Recycling Efforts Bear Fruit

Calendar year 1998 will go down as a milestone in the Village's efforts to

reduce its waste stream. For the first time since 1990, when the Village first began tracking recycling data. residents actually sent less trash to the Charles Point incinerator than they had in the prior year, 1997, and even At a recent Village Board 1996. meeting, Recycling Liaison, Trustee Linda Pohlmann, pointed to a surge of newspaper and cardboard recycling. However, she also noted that there was a slight dip in bottle and can recycling which might be attributed to more people returning redeemables to the store. All in all, it was a good year for Ardsley's recycling efforts. Besides environmental the benefits of recycling, the Village reaps a savings of about \$22 for every ton not sent to the incinerator.

Ashford Ave. Project Back on Track

Thanks to the combined efforts of Mayor Sam Abate, Trustees Jay Teitelbaum and Bernie Preisser, and Village Manager George Calvi, with a big helping hand from State Senator Nicholas Spano, the reconstruction of Ashford Avenue and the intersection with Route 9A has been placed back on New York State DOT's schedule, and even enhanced.

Bids for the redesign of the Ashford Avenue/Route 9A intersection will be let October 1999, and the bids for the portion of Ashford Avenue stretching from approximately the Bank of New York to Sprain Road will be let in April 2000. The intersection work is a 100% cost of the State of New York. The cost for the remainder of Ashford Avenue will be divvied up by a formula devised by the State with between 3% and 5% being allocated to the Village of Ardsley. The one silver lining to the delay of the project has been the subsequent inclusion of certain curbing and sidewalk work in an area along Route 9A from Bridge Street to Center Street which will also be a 100% New York State charge.

Other improvements for Route 9A which had been requested by Village officials this past summer are being considered for inclusion into the current capital program though a timetable has yet to be established.
