EVO RIGUZZI, JR. DAY PROCLAIMED

At a Village Board meeting on July 6, 1992, Mayor Morehouse presented the following proclamation:

Whereas, Colonel Evo Riguzzi, Jr., Commander of the 800th military Police Brigade, Uniondale, New York, entered the U.S. Army in May 1968 and was commissioned a Second Lieutenant after completing the Reserve Officer Training Course at Gannon College, Erie, Pennsylvania, and whereupon graduation, he served as a Security Platoon Leader with the 69th Ordnance Company, 559th Artillery Battalion, in Vicenza, Italy, and

Whereas, since joining the Army Reserve in 1970, Col. Riguzzi has served in various staff positions in the 340th Military Police Battalion, culminating in his assignment as Battalion Commander in July 1981, and

Whereas, in 1984, Col. Riguzzi was assigned chief of the training division at headquarters of the 77th Army Reserve Command, and upon his selection to Colonel was reassigned as the Commandant of the 1150th United States Army Reserve School, Fort Hamilton, New York, and

Whereas, Col. Riguzzi served as executive officer of the 800th Military Police Brigade during Operation Desert Storm, which unit was assigned to Saudi Arabia and performed all missions pertaining to enemy prisoners of war,

and which unit he took command of in November 1991, and

Whereas, Col. Riguzzi has been decorated with the Bronze Star medal, four meritorious service medals, three Army commendation medals, four Army Reserve component achievement medals, the National Defense Service Medal, the Armed Forces Reserve Medal, the Southwest Asia Campaign Medal with two campaign stars, the Army Service Ribbon, and the Overseas Service Ribbon, and

Whereas, in his civilian life, Evo Riguzzi, Jr. was born in White Plains, resides in Ardsley with his wife, Sharon, and their four children, and is Director of Corporate Security and Consumer Affairs for the Home Insurance Company, and

Whereas, on Saturday, July 11, 1992, Col. Evo Riguzzi, Jr. will be promoted to the rank of Brigadier General in the United States Army Reserve at the Ernie Pyle Reserve Center, Fort Totten, Queens, New York,

Therefore, I, E. John Morehouse, Mayor of the Village of Ardsley, do hereby proclaim Saturday, July 11, 1992, as Brigadier General Evo Riguzzi, Jr., Day, and hereby do call upon the officials of the Village and all citizens thereof, to render acclaim to this highly respected and dedicated citizen/soldier. In witness thereof, I have hereunto set my hand and caused the Great Seal of Ardsley, New York to be affixed, on this, the 11th day of July, Nineteen Hundred and Ninety-two.

E-911 SYSTEM ON ITS WAY

It is anticipated that within the next twelve months the Westchester County E911 Systems will be operational. For the past two years members of the Ardsley Police Department have been working toward implementation of the system by verifying residences, private and public telephone, and jurisdictional boundaries. While in the process of checking buildings (both residential and commercial) it was noted that there are a good number of private residences and commercial buildings that do not have their building numbers posted in a conspicuous manner. If you have not already done so, please cooperate by placing your building number near the entrance. Pursuant to our Village Code, these numbers must be at least two (2) inches in height. In responding to an emergency, it is extremely important that the Police and other emergency personnel be able to promptly identify the correct building. If you have any questions regarding the E911 System, do not hesitate to telephone either Police Chief Louis D'Aliso or Police Officer Evan Kanigher.
