Mr. Conrad Roncati presented himself to the Board and reminded everyone that at the last Planning Board meeting the suggestion was made for additional plantings to be placed on the corner of Revolutionary and Saw Mill River Roads. The site plan drawing has since been amended to include five evergreen trees along the side of the building to block the wall from the view of the northbound vehicles on Saw Mill River Road. Additionally, the parking has been screened with shrubs along the sidewalk and an additional evergreen.

The landscape plan indicates the species and the types of plants which will be placed in the area. The evergreens will be dwarf Alberta spruce. The red maples along Route 9A will grow to a height of approximately 25 ft.

Mr. Roncati pointed out, per Mr. Paley's request, the pathway which allows walking from the project to the shopping center.

Mr. Greechan explained that the storage unit chambers have been redesigned and placed in the proper areas.

Messrs. Petretti and Greechan approached the Board with the proposed site plan. Discussion was undertaken and Mr. Petretti explained that the proposal was for a three lot subdivision, all of the lots meet the requirements of the Code after the steep slopes are deducted.

The question of whether or not the paper street on which the property was located, was owned by the Village was discussed. Mr. Petretti explained that a title search would need to be done.

The issue of site distance was discussed and concern was expressed by Mr. Preisser as to the problem with the curve and the fact that he has had problems with the area.

The issue of the proposed cul-de-sac was discussed and concern was expressed by Mr. Paley for the large size of the cul-de-sac. Mr. Petretti agreed to reduce the size, if possible.

Mr. Petretti explained that each of the lots was larger than Code, however, given the 130% rule, they meet the Code. The sewer and water lines will be easy to deal with, according to Mr. Petretti.

Mr. Petretti suggested the Board walk the site to view the storm water management plan, of which there is an overabundance in place. The Village will maintain the drainage equipment, according to Mr. Petretti. Discussion ensued regarding the likelihood of the Village agreeing to this responsibility.

Mr. Parnes stated that the drainage of the lots seemed as thought it would be challenging.

The steep slope issue was discussed on a lot-by-lot basis.

Mr. Parnes and Mr. Paley expressed their concern regarding the size of the proposed culde-sac. Possible alternatives were discussed.

The run-off issue was discussed on a lot-by-lot basis by Mr. Petretti. The final destination of the run-off is unknown, however, Mr. Petretti agreed to investigate this and determine where it ends up.

Mr. Parnes noted that a public hearing should be held next month and reminded Mr. Petretti that notifications will need to be sent. Mr. Parnes requested a copy of the deed, a list of all permits being sought and a rendering or an elevation.

Mr. Petretti mentioned that he would be staking out the lots and requested the Board do a site walk prior to the public hearing.

Mr. Parnes requested that the adjacent properties be shown on the site plan, including the contours.

Mr. Petretti agreed to respond formally to Mr. Tomasso's written comments regarding this project.

Mr. Petretti discussed the site distance issue and defended his placement of the cul-desac.

The existing house on the property will be demolished.

The Board decided to they would walk the property individually, prior to the next meeting.
