Last month the Applicant was waiting for the Board of Trustees to complete the SEQRA process and Ms. Giris stated that the Board did complete the SEQRA process and also stated that the Board adopted a Declaration back in April 2015. Ms. Giris stated that the Applicant was at the BAR two or three different times and the design of the building has received a favorable review. Mr. Soudan displayed the drawings to the Board and discussed the colors on the building. Mr. Soudan stated that there will be elevator access and rolling carts at the storage facility. Mr. Soudan further stated that the hallways are motion censored and the back of the building is for emergency access only.

Mr. Pellegrino asked Mr. Tomasso if there are any stormwater or drainage issues. Mr. Tomasso stated that the final decision is to be worked out but the basic parameters are that they are all in place and basically it is dumping water into the wetland and floodplain. Mr. Tomasso stated that issues were already addressed on the original plans but now that the building is larger, they have to possibly be resized and it is nothing that cannot be done during the construction phase.

Mr. Pellegrino asked if anyone has appeared from the other side of the River and Mr. Tomasso stated that the only one person that showed up throughout all of the Public Hearings is the plumber across the street who owns the little shack and the plumber stated that "the building is beautiful."
