3. DEPARTMENT REPORTS

1. LEGAL

1.a Village Attorney, Robert Ponzini stated he had nothing to report other than those items that may have been submitted in memorandum form and would be available for Executive Session after the meeting if needed.

Trustee Weitz questioned memorandum form and would like a legal update.

Village Attorney Robert Ponzini stated that he issues a memo on topics that requires a memo such as certiorari claims.

Village Manager Cerretani explained that many of the legal updates are not up for discussion in a public forum.

2. MANAGER

- 2.a Village Manager Joseph Cerretani read the following report:
 - 1. **POLICE ACCREDITATION:** I unfortunately was unable to make the last Legislative Meeting of the Village Board, but I did want to express my sincere congratulations to Chief Piccolino and the Ardsley Police Department for being recommended for accreditation. I had the privilege of meeting with the assessors from the Division of Criminal Justice Services throughout their few days here in the Village and going through a detailed debriefing session where they were able to articulate their findings. I was very impressed with both the depth of detail that the assessors demanded as part of their inspection, and the immediate and flawless response given by the members of the Police Department. Throughout the debriefing, the assessors had made numerous comments about the level of preparation by the entire department. Another comment that was made is that the auditors were almost equally as impressed with the inter and intra departmental communication and teamwork that they observed and how unusual it is to see that in a local government. I am very proud of Chief Piccolino and the entire police department on their

performance and would like to congratulate them on their recommendation for becoming an accredited agency.

- 2. **SANITARY/STORM SEWER MAPPING PROJECT:** Fred Cook is continuing to perform the closed camera television recording work. So far there is nothing major to report, which is good news. Due to holidays and potential weather delays, we anticipate this phase of the project being complete by the end of the month.
- 3. **NEW DPW CONSTRUCTION PROJECT:** The project is continuing to make progress through the winter. We are out on the site this afternoon. The steel rebar for the footings has been installed and the crew began their first concrete pour today for the footings located along the rear of the future buildings. Contractors will try to capitalize on the current weather conditions and continue as long as conditions allow.
- 4. **SCHOOL CROSSING GUARDS:** We have advertised for a second crossing guard position to assist with pedestrian safety. Chief Piccolino is reviewing applications and scheduling interviews. We hope to have an appointment made in the next two weeks.
- 5. **HOLIDAY SCHEDULE**: All Village Offices, including the Justice Court, the Library, the Community Center, and the Department of Public Works will be closed on Monday, January 16, 2023 in observance of Martin Luther King Jr. Day. There will be no refuse collection that day. There WILL BE refuse collection for the entire village on Tuesday, January 17, 2023.
