Mayor Kaboolian read the following statement:

Before we get started, I want to remind everyone again that the public hearing on this matter will NOT be closed and no approvals will be made tonight. There will be no time limit for comments, but I ask that you identify yourself and try keep your comments as brief as possible.

This board referred the application to the Zoning Board for a determination of whether the non-conforming gas station had been abandoned and for an interpretation of section 200-100D of the Village Code.

The Zoning Board was asked to decide a question involving the interpretation of the Village Code. The standard of review for the Zoning Board is one of "substantial evidence" – this standard consists of proof from the whole record to persuade a fact finder that from that proof a conclusion may be extracted that is reasonable, probative and logical. Multiple public hearings were held by the Zoning Board.

The Zoning Board resolved on January 24, 2018, that the use of the property as a gas station had NOT been abandoned and the use of the property for servicing cars had been abandoned.

Following this determination an Article 78 proceeding was filed. An article 78 proceeding is a supreme court case to review or challenge decisions of administrative bodies. It is called an Article 78 proceeding because that is the Article number under NY law.

On July 30, 2018, the Supreme Court found that the matter was not ripe for judicial review and dismissed the petition.

The Court of Appeals affirmed but stated that the petition should have been dismissed on the grounds that the petitioner lacked standing. To have standing the petitioner must be able to show harm or injury different from injury suffered by the public at large. The Court of Appeals found that the petitioner failed to allege direct harm. The Court of Appeals did not address the determination of the Zoning Board.

The application has been before the Planning and BAR for review and comment. Each one of these boards held public hearings on this matter. The minutes of all these meetings can be found on the Village website.

This Board is guided by the decision of the Zoning Board and the Court decisions and since that finding is undistributed at this time, we are moving forward with the applicant's request for site review.

The is a site plan approval process.

We have received additional comments from the public. All these comments will become part of the record.

Over the past few weeks, we have read all the comments received, I reviewed the last board meeting, we met with our attorney and asked for additional information from our building department and consultant.

As we move forward, I implore everyone to be respectful to each other at these meetings and on social media. Everyone is entitled to their opinion and to be heard on the matter.

I also want to remind people not to get their information from social media. I have seen misinformation circulated.

The best resource for information is from this board and these public meetings. Please attend, listen, and comment. That is the fundamental purpose of a public meeting.

I also want to add that comparing other projects in this Village or from neighboring villages is like comparing apples to oranges. Projects are different, circumstances are different, histories of the projects are different.

We need to address the proposal in front of us with the facts and background of this proposal. That is our mandate.

We are here again to listen and for the board and others to ask questions and to seek more information from the applicant.

Diana Bunin Kolev representing the applicant from DelBello Donnellan Weingarten Wise & Wiederkehr, LLP was present to answer any questions that the Board might have and would like a better understanding of which one of the proposals they should proceed with.

Trustee Bencosme read the following questions:

We understand it has been a long process to get the application to this stage. My understanding is that the tenant found spill incidents that had to be reported to the Department of Environmental Conservation, including spills that contaminated ground water & soil.

• Can you please share what you found, what you had to remediate as well as

what you plan to do to prevent this from happening again by continuing to maintain a similar land use?

In my research of what triggered the need for remediation, given we are going through a state environmental quality review process, I did find various spill incidents. There are spill incidents dated 4/20/2016, 4/13/2018, 11/20/2018 that do not appear to be closed

- Please can you help us understand the current status of remediation and why these incidents might be not closed on DEC's public database?
- Are you aware that Governor Hochul has legislated that 100% of in-state sales of new passenger cars and trucks, off-road vehicles and equipment have to be zero-emissions by 2035, medium-duty and heavy-duty vehicles by 2045?
- This means the transition is happening now and must be complete in the next 11 years. Have you considered the addition of more than one EV charger given the significant transformation that is happening in the transportation sector? And whether there could be opportunity to provide more charging, especially given there are no municipal or commercial chargers in Ardsley?
- It was noted in the proposed site plan that 70% of this site will be impervious surface. Given its location at the bottom of a number of steep slopes and that there is a tributary that goes to the SawMill River adjacent to the property, has any consideration been given to reducing the extent of impervious surface, including more permeable surfaces and including green infrastructure to mitigate the increased flooding we are having in that area?

Given the transition we are going through in the transportation sector, we will all need fast charging sites. I encourage you to evaluate how many Level 2 and 3 chargers can be installed, including evaluating the grid's transmission capacity for this site. Additionally, there are significant state and federal incentives that can largely offset the cost of EV charging.

Sammy Eljamal stated the following:

- They could do four (4) EV chargers.
- Reported contamination to the DEC back in 2016.
- Requests that we close the public hearing as soon as possible.
- Agrees to construct sidewalk on Ridge Road and pedestrian safety is a concern.

Trustee DiJusto:

- Appreciates the extra EV chargers.
- Concerned about the catch basin/storm drains and hopes that they flow more

south of the property.

• Concerned about the traffic flow at that intersection of this property.

Mayor Kaboolian and the board requests:

- Traffic study.
- Drainage study.
- Lighting study.
- Stormwater study.
- Landscape Architect study.
- Plan with the four (4) EV charging stations.
- Ensure that this plan goes forward as environmentally sound moving forward.
- Will be referring this plan back to our Board of Architectural Review.

Trustee Bencosme added that the number of EV chargers that can be installed will be determined by the infrastructure and there are significant state incentives for these chargers.

Mayor Kaboolian asked the applicant to meet with the Building Inspector so that we can move forward.

David Smith, Ardsley Planning Consultant asked if the applicant can have the material prior to the December 18th, 2023 meeting.

Moved by Trustee DiJusto, Seconded by Trustee Bencosme and passed unanimously.

RESOLVED, that the Public Hearing be continued to the December 18, 2023 Board Meeting in the matter of the proposed development located at 657 Saw Mill River Road in the Village of Ardsley at 9:26 pm.

<u>DPW PROJECT UPDATE:</u> In continuing with our Department Quarterly updates, tonight we have Public Works General Foreman David DiGregorio here with us, and he will provide an update on the DPW facility project.

RAINSTORM OF SATURDAY, OCTOBER 7: We observed significant rainfall on Saturday, October 7, with flooding in some areas in the Village. We had one road closed temporarily, which was closed for 2-3 hours. I encourage all residents who have not done so already to sign up for Nixle alerts to stay informed, especially during emergencies and severe weather events. Thank you to Village Clerk Ann Marie Rocco who helped in getting the notifications out and keeping the public informed. I also want to thank all of our first responders, including the Department of Public Works, Police Department, Fire Department and ASVAC for their tireless efforts to keep the Village safe during the event.

CURBING & PAVING: All of the curbing work for 2022 and 2023 is now complete. There is some restoration work with respect to topsoil and seeding that will be completed in the spring, but the concrete work is complete and ready for paving. The roads that were curbed between both contracts were Felix Ave, Lakeview Ave, Sweetbriar Rd, Lincoln Ave, Euclid Ave, Huntley Dr and Oak Hill Rd. ConEdison paving crews will be out beginning Wednesday this week and should be finishing early next week to restore roads that were disturbed as a result of recent gas main upgrades. They will be paving Ridge Rd, Bramblebrook Rd, Augustine Ave, Hillside Pl, Bonaventure Ave, and a section of Fuller Ave. Additionally, the annual paving program for the Village will include the paving of Sweetbriar Rd, Lakeview Ave, Euclid Ave, Oak Hill Rd and Huntley Dr and will begin next Monday the 23rd and should be done by the end of the week.

ARBOR DAY EVENT: We will be hosting an Arbor Day tree planting event this Saturday, October 21 at 9am at Pascone Park. We encourage the community to participate, all materials and supplies will be provided. We are excited to continuing this important tradition, as well as maintaining our designation as a Tree City.

9. CORRESPONDENCE

9.1 Hello,

We are writing to express our opposition to the reconstruction of a gas station on the corner of Ashford and Saw Mill River Rd. As Ardsley residents and parents, we are invested in the continued growth and development of the village on every level- we are excited about the vision for revitalizing the village square and would love to see Ardsley thrive economically, culturally and environmentally.

It is because we want to see Ardsley succeed that we strongly believe it is not in the village's best interests to redevelop the gas station on this corner. First, it is noteworthy thatnwe have not suffered from the absence of another gas station in the area: between the three existing gas stations in fairly close proximity along Saw Mill River Rd., we have enough options when it comes to filling our cars. If anything, its absence may have helped a tiny bit with the existing traffic and bottlenecks that regularly occur at the intersection- adding another gas station right at this location would surely exacerbate what is already a frustrating driving experience.

Any issues with the existing space were caused in part by the station being abandoned for over 6 months, with no communication or acknowledgment from the owner until very recently. Per the law, abandonment of land past 6 months without any communication from the owner entitles the village to rezone. The owner had ample opportunity to communicate their plans, but opted not to do so. Outside of this, adding a gas station would not align with the village's plans for beatification, indeed it would accomplish the opposite and make Ardsley a less desirable space for residents, neighbors and prospective future residents. Frankly, other than the chain link fence, the wildflowers in the vacant space make for a far more beautiful space than the proposed development. Ardsley would gain more value from having more communal spaces, such as restaurants, retail, or residential development. Having something along those lines in that intersection would go a long way towards revitalizing the village square per the planned beatification- it is a central location that could highlight all of the things that makes Ardsley special.

Furthermore, gas stations are known to add toxicity to the land and cause environmental harm to neighboring spaces, specifically residences. Understanding that we are increasingly moving towards a future where about half the cars on the road will be electric, there is limited long-term economic benefit to the village and great risk of long-term environmental harm.

We hope you will take these points to account, and join us in recognizing that not only will restoring the gas station not benefit Ardsley, but will actually cause harm.

I saw there is a meeting of the village trustees on 10/16 re the proposed new gas station at this address, I wanted to share some notes as a resident of a neighborhood directly affected by this. I appreciate you sharing them however appropriate, but I'll do my best to be present at the meeting.

The junction of the Saw Mill onto Ridge/Bramblebrook (opposite the bakery) is already out of control - there are vehicles (private, commercial and local authority) parked in the no parking signage 24/7, making access in and out horrendous. There are ALWAYS vehicles parked there blocking safe view of the junction. Everyone in our neighborhood has had multiple near misses with vehicles on the wrong side of the road traversing parked vehicles. Particularly given the number of large heavy vehicles parked there. 9.6 Hello,

Please share my written comments with the Board of Trustees.

I oppose the new Foodsmart with gasoline pumps. The village should rezone the property to allow multi-family residential with ground floor retail.

Please ask the owner if he would consider instead developing a multi-family apartment building if the village rezoned it. That might be the highest and best use of the property.

Ardsley is not building enough new homes. Our population grew 14% from the decade from 2010 to 2020, but the housing stock grew only 5% over the same period. (see attached) Housing is only getting more expensive. Our children are graduating college and can't afford to live in Ardsley, and will instead have to move into cramped NYC apartments with 3 roommates. Our seniors are stuck in homes larger than they need, and they can't downsize into apartments.

New York State Governor Kathy Hochul, a Democrat, launched a pro-housing communities program to prioritize \$650 million in state discretionary funding to localities committed to housing growth. Applications are open. Localities who submit documentation that their housing stock has increased by 1% in the previous year or 3% over the previous three years will qualify for certification. In Ardsley, that would

be 17 or 52 new homes. Do you want to apply for some of those funds? With our property taxes seeing the single largest increase in 10 years, +14% over last year, those state funds sure could help.

Does Ardsley want to continue to be part of the problem and make it unaffordable to live here, or part of the solution and build more housing?

New Yorkers agree; housing has gotten too expensive. For decades, New York has not been able to build nearly enough housing for everyone who wants to call New York home. The housing shortage is not only driving rents, home prices, and other housing costs to record highs — it's keeping workers and families from achieving the New York Dream.

Governor Kathy Hochul has laid out a bold vision to address New York's housing crisis by increasing the housing supply, and she remains committed to working with the Legislature to make the State more affordable and more livable for all New Yorkers.

The cost of housing in New York State is among the most expensive in the nation. 9.11 Submitted by Eda Kapsis, resident, Village of Ardsley. Comments for the record of the October 16, 2023 2ndpublic hearing re: proposed plans for development of a new gas station to be located at 657 Saw Mill River Road at the corner of Ashford Road.

I remain opposed to this plan. The 1st hearing clarified that this proposed contradicts the interests of all Village stakeholders including businesses, residents, educators, and those who pass through on the State 9A.

I ask the Board to open an inquiry into the decision of the Village Zoning Board to grant a permit for this business project. The publicly available minutes cite concerns and it is appropriate to investigate the Zoning Board's procedures and their vote to grant this permit.

I ask the Board to engage legal experts to consult on remediation of the site. Significant gaps remain clearly reported in the public records. And given the extended and complex legal wrangling underway, I suggest that the Board hear from specialized legal counsel to guide review of those clear gaps.

I ask the Board and Village Manager to inform registered Village voters on the process and requirements to bring a measure relevant to this proposal to a vote on a Village ballot. Voting stakeholders have contributed substantially to plans for the Village over many years as this applicant has pursued their proposal. The voters should vote on a ballot measure to decide the outcome for this prominent location and against the backdrop of the Village Comprehensive Plan and pending Implementation Plan.

Finally, for the youth and all stakeholders who live and work in the Village now and in the future: efforts to oppose this proposal are hampered by outdated legal codes and

procedures. And as of 2023 the municipality is not required to plan to meet nor actually comply with the 2019 state CLCPA targets by any measure. These hurdles are significant, but it is clear that the majority of Village stakeholders oppose this proposal and those who can shall persevere. Thank you.
