IV. DEPARTMENT REPORTS:

LEGAL REPORT:

Village Attorney Ponzini had nothing to report other than certain items that he is working on with the Village. We do have one small tax matter that we are going to settle. It is a holdover from when we had our assessment roll and he should have it on the agenda in the next couple of weeks. Mr. Ponzini stated that he is available for an Executive Session if necessary.

MANAGER'S REPORT:

VILLAGE MANAGER REPORT FOR MONDAY, OCTOBER 5, 2015

- 1. The completion of the storm hardening work being done in front of Village Hall by Con Edison has been postponed due to an accident with the machinery that took place a week ago. Thankfully, there were no injuries and property damage was minimal. The project has been stopped while an investigation into the accident is completed. We are hopeful that the delay will be no greater than three weeks.
- 2. The Village will be bringing on a new payroll vendor which will provide enhanced services, including assistance with the ACA reporting requirements, at a significantly reduced price. The new system should be in place for the second payroll of this month.
- 3. I am extremely happy to report that our fund balance has received a much needed boost as of the end of the last fiscal year. Based on initial auditor review, we will be increasing our fund balance by approximately \$550,000. Though this will still leave the Village shy of the balance at the end of the 2013-2014 fiscal year, and significantly less than the balance at the end of the 2007-2008 and 2008-2009 fiscal years, this is still a great step in the right direction to protect the Village's fiscal health. This will presumably allow us to get off the list of fiscally stressed municipalities that the State Comptroller's Office determines. For those who have seen the latest reports from the State Comptroller's Office, that had nothing new to do with Ardsley at this point in time. The reason the list made "news" again was because the Comptroller's Office just released a new report which included calendar year communities. Ardsley was identified back in the winter when they reported on non-calendar year municipalities based on the prior fiscal year. The news has only gotten better since then.

TREASURER'S REPORT: Village Manager read the Treasurer's Report on behalf of Marion DeMaio.

Ms. Robson stated the bills for the past two weeks totaled as follows: General Fund: \$81,794.48; Trust & Agency Fund: \$5,825.72; and from the Capital Fund: \$879.50.

Trustee Kaboolian: RESOLVED, that the Village Board of the Village of Ardsley hereby authorizes the Village Treasurer to make the following payments: From the General Fund: \$81,794.48; From the Trust & Agency Fund: \$5,825.72 and from the Capital Fund: \$879.50. **Seconded by Trustee Malone and passed unanimously.**

- I signed plans for the storage facility at the building inspector's request
- We received word that Town of Greenburgh has declared itself Lead Agency on the Jefferson Housing Project on Lawrence Street; that is the preliminary step to the formal process; there are certain parties that a have a right to object within thirty (3) days and if not, the town will proceed as the Lead Agency and the formal process will start which is first a submission of a draft environmental impact statement and once that is adopted, they will have an opportunity to address that and raise concerns that we have at that project

- I went on the Facebook and Twitter sites today. We are on Facebook and not on Twitter. The sanitation schedule for October was posted there


