#### 8:00 P.M. - PRESENTATION- RECOGNITION AWARDS - POLICE OFFICERS

Chief Califano awarded the following police awards for the period 2010 – 2011:

The Ardsley Police Awards were created to recognize sworn members of the Department and civilians that distinguish themselves by performing a service over and above what is normally expected in similar circumstances.

In addition to recognizing Village of Ardsley Police Officers for their outstanding work for the years 2010-2011, this year we will also be recognizing an officer from Tarrytown PD, as well as 3 civilians.

## 2010 Award Synopsis'

PO Davis & PO Danny Watson step forward.

1- On November, 9<sup>th</sup>, 2010, Officers Ed Davis and Daniel Watson responded to what appeared to be a routine medical call for service at the Woodlands Atria. However, upon arrival, the Officers found the person in need of routine medical aid was actually found to have no pulse and was not breathing. CPR was immediately conducted by the officers and a normal pulse and breathing was re-established. For their prompt and professional application of first aid, which resulted

in the saving of a life, the award of "Life Saving" is granted to both officers.

Detective Sheeley, Detective Perkins & PO Roemer step forward.

2- During the mid-months of 2010, a group engaged in purchasing store gift cards using stolen credit cards in an effort to defraud and steal merchandise from the Rite Aid Pharmacies throughout the East Coast. This crime spree ended for all three suspects in July of 2010, when Officer Brian Roemer and Detective John Sheeley, arrested the suspects, while fleeing from Rite Aid in Ardsley, after they attempted to make another fraudulent purchase. A subsequent investigation found these suspects to be associated with a crime ring responsible for the theft of nearly \$1 million dollars in stolen merchandise from 9 states. For their part in the apprehension, subsequent investigation and conviction of all three suspects, Officer Roemer, Detective Sheeley, and Detective Perkins are granted the award of "Meritorious Duty".

Detective Sheeley, PO Gannon & PO Roemer step forward.

On July 15<sup>th</sup>, 2010, Off-Duty Officer Keith Gannon observed and attempted to stop a possible DWI travelling south on Route 9a in the Village of Ardsley. This vehicle narrowly missed striking Officer Gannon's personal vehicle head-on. Unable to stop this vehicle, the concerned off-duty officer called ahead to marked units and had this car stopped. The driver was found to be highly intoxicated and was travelling with two small children in the vehicle. The actions by this off-duty officer as well as the prompt actions by Detective Sheeley and Officer Roemer led to the driver being charged with four felony counts of DWI and possibly averted a tragic accident in the making. Officer Gannon is granted the award of "Excellent Duty" and Detective Sheeley and Officer Roemer are granted the award of "Unit Citation".

Detective Sheeley, PO. Joseph Barosa step forward

- While assigned to the Greenburgh Drug and Alcohol Task Force, on May 18<sup>th</sup>, 2010, Detective John Sheeley and Officer Joseph Barosa of the Tarrytown Police Department observed a vehicle operating aggressively while in the village of Ardsley. The vehicle was stopped and a subsequent investigation was conducted. This investigation led to the discovery of 70 pounds of marihuana located within the vehicle. The driver was arrested and charged with Criminal Possession of Marihuana in the 1<sup>st</sup> degree. For their vigilant and professional actions, both officers are granted the award of "Excellent Duty".
  - \* Note- Officer Barosa becomes the first officer from an outside agency to receive an award by the Village of Ardsley.

Sgt Dave Fisher, PO Daniel Watson, PO Edward Davis step forward.

5-During the spring months of 2010, a rash of car break-ins over several jurisdictions in Westchester County, including Ardsley, occurred and numerous GPS devices were stolen. On May 9<sup>th</sup>, 2010, without any description of known suspects, Officer Dan Watson observed a party acting suspiciously near a bus stop on Rt. 9a. Upon approach, Officer Watson engaged the person in conversation while also observing that the party had blood on his hand. This conversation led to the arrest of this person for four car break-ins which occurred in Ardsley earlier that day. The subsequent investigation by Officer Dan Watson, Sergeant David Fisher, and Officer Ed Davis led the suspect being charged with several felony counts of criminal mischief and possession of stolen property, as well as, closing out many open cases in other jurisdictions. Officer Watson is granted the award of "Excellent Duty" and Sergeant Fisher and Officer Davis are granted the award of "Unit Citation".

## 2011 Award Synopsis'

### Civilian Awards:

Po Bryan Watson & Mr. Malik Bradford step forward

1-On May 2, 2011, Mr. Malik Bradford was working in his home, when he heard a noise at his neighbor's home. Looking out the window, Mr. Bradford observed his neighbor's basement door open and a strange truck parked in front of his home. Knowing his neighbor was not at home; Mr. Bradford became suspicious and notified the police. Mr. Bradford provided a description of the truck and of the driver who returned to the vehicle. Officer Bryan Watson arrived and confirmed that a burglary had taken place. The descriptions provided by Mr. Bradford were the key factors in Officer Watson's ability to locate and arrest the party involved shortly after. Due to the prompt awareness of the situation, Mr. Bradford along with the keen observations of Officer Bryan Watson, the person who burglarized Mr. Bradford's neighbor's home was apprehended. Therefore, Mr. Malik Bradford is awarded the "Citizen's Medal for Excellent Service" and Officer Bryan Watson is awarded "Excellent Duty".

## Mr. Eduardo Alonzo step forward

On September 14<sup>th</sup>, 2011, the fire alarms from #39 Riverview Ave. 2began to sound at 2:00 am. The home owner, who was at home with his family asleep, searched his house but found nothing wrong. He attempted to reset his alarm as the family went back to bed, only to have his alarms go off again. Not sure of what to do, the home owner decided to seek the advice of his neighbor, Mr. Eduardo Alonzo. Mr. Alonzo was woken up at 2:15 in the morning and advised of the situation and quickly realized that something was not right. Mr. Alonzo advised him to get his family out of the house and he contacted the police. The fire Department arrived and tested for carbon monoxide. It was reported that the levels of carbon monoxide were so high, that the family would not have survived the night. Mr. Alonzo's prompt awareness for the situation and his smart advice, possibly saved the lives' of two adults and two young children; therefore, Mr. Alonzo is granted the "Citizen's award for Excellent Service".

Mr. Joseph Brunetto step forward

3-On August 20<sup>th</sup>, 2011, an elderly male was reported by Yonkers PD, to be over-due at his home and that the family was concerned he may be confused due to a diabetic emergency. At approximately 11:45 am, the driver was now driving Eastbound on Ashford Avenue near McDowell Park, when a diabetic shock caused him to pass out. The driver lost control of his car, ran off the road, flipped his car onto his roof, which then caught fire and slid to a stop upside down in the roadway. Mr. Joseph Brunetto, driving the other way witnessed this crash and knew he had to help. Mr. Brunetto selflessly decided to risk personal injury to his self and ran towards the flaming car. Once Mr. Brunetto reached the car he forced open the door and without regard for his own safety, he reached in and pulled the driver out of the burning vehicle. Mr. Brunetto's brave actions at grave personal risk to himself certainly saved a life that morning and therefore, is awarded the "Citizen's Medal of Distinction".

## Officer's Awards:

PO Keith Gannon & PO Daniel Watson step forward

4- On June, 5<sup>th</sup>, 2011, Officer Daniel Watson was on routine patrol, when he observed a suspicious vehicle driving quickly on back roads in the Village of Ardsley. After following this vehicle a short distance and observing several more infractions, he knew something was not right. Officer Watson attempted to stop this vehicle, however, the driver decided to flee instead. A lengthy pursuit followed which also involved Officer Keith Gannon from Ardsley, as well as several other jurisdictions. The pursuit of the vehicle continued throughout Yonkers, where eventually the suspect crashed his car and then fled on foot. He was shortly apprehended and along with crack cocaine; a loaded hand gun was recovered. Due to Officer Watson and Officer Gannon's actions, an illegal hand gun was removed from the streets; therefore the award of "Meritorious Duty" is awarded to both officers.

#### Lt. Carl Calabrese step forward

On July 30<sup>th</sup>, 2011, Lt. Carl Calabrese was on routine patrol, when he observed a vehicle commit several traffic infractions. Lt. Calabrese stopped the vehicle and interviewed the operator. During the course of the interview with the driver, it became apparent to Lt. Calabrese that the operator was attempting to conceal something. The driver was arrested for driving with a suspended license and a subsequent inventory search of his car, discovered that the driver was attempting to conceal a large quantity of cocaine and heroin. Lt. Calabrese's professional attention to detail resulted in the driver being charged with multiple felony counts of possession of a controlled substance. Lt. Calabrese is granted the award of "Excellent Duty".

#### PO Daniel Watson step forward

On April 7<sup>th</sup>, 2011, Officer Daniel Watson observed suspicious activity of a possible drug transaction in Addyman Square. The vehicle in question was also observed leaving the area in violation of several traffic infractions. The vehicle was stopped by Officer Watson and the driver was determined to be in possession of numerous bags of marihuana. The subsequent investigation conducted by Officer Watson led to the additional seizure of another ½ pounds of marihuana at the Ardsley resident's home. For Officer Watson's diligent observations he is granted award of "Excellent Duty".

Detective John Sheeley & PO Michael Stevenson step forward

On January 1<sup>st</sup>, 2011, Officer Michael Stevenson stopped a vehicle for making an illegal turn from the CVS parking lot. Routine Motor Vehicle check showed the driver to have a suspended NYS license. Detective John Sheeley arrived on scene as the backup Officer. Prior to impounding the vehicle, both Officers conducted a routine vehicle inventory search. During the search, several credit cards were found that did not belong to anyone in the vehicle. Also found was an envelope containing \$1,100 in counterfeit cash. For P.O. Stevenson

and Detective Sheeley's investigative efforts, they are granted the award of 'Excellent Duty"

Detective John Sheeley step forward

- 8- On May 7<sup>th</sup>, 2011, Detective John Sheeley stopped a vehicle for routine traffic violations. During the stop, Detective Sheeley was able to discover the driver was in possession of what is called a "credit card skimmer". This illegal devise is used to steal people's credit card information and perpetuate identity fraud. Due to his investigative efforts, Detective Sheeley is granted the award for "Excellent Duty".
- 9- On July 10<sup>th</sup>, 2011 Detective John Sheeley responded to a suspicious vehicle complaint at an address on Fairmont Ave. Detective Sheeley located the vehicle occupied by two people. Upon approaching the open passenger side of the vehicle, Detective Sheeley observed the passenger trying to conceal a Ziploc bag inside his sock. The passenger was asked to exit the vehicle. Detective Sheeley discovered a large amount of cocaine inside the bag hidden in the suspect's sock. Also found was drug paraphernalia consistent with the use of cocaine. For his investigative efforts, Detective Sheeley is granted the award of 'Excellent Duty'.

There is printed material regarding the program available at the library. Next year, the pet bio-baggies will again be made available. There is a stormwater program which has been running all year on cable television, a new program will be developed within the next week or two. The third-annual Concord Road forth grade stormwater awareness program will be repeated. In July, the Saw Mill River Coalition Groundwork Hudson included the Pascone Park on their tour.

The scouts and high school students were thanked for their participation in the stormwater program.

A Bronx River watershed initiative ground project was conducted this year. In 2011, the County stormwater law was passed which established six basin-wide advisory boards. A clean up of the Saw Mill River has begun. Local businesses are being encouraged to help out with the effort.

Annual inspections of outfalls are continuing.

There were no violations issued this year to the program.

The Atria Woodlands has developed a maintenance plan for their bio-retention basin. The flood control wall in Ardsley will be repaired. The Highway Department has been clearing trash and invasive vines on the banks of the Sprain brook and Saw Mill River as well as keeping the catch basins clear. The storm drains continued to be mapped.

Thanks were extended to the Village Hall staff for their involvement with the program.

Five are "grandfathered" as a retail/business use parking and four off-street spaces are available behind the building. Any future increase in the number of bikes and/or the offering of additional services must be reviewed by the Village Board.
- 2. The applicant must provide plans showing compliance with the NYS Building Code for the interior alterations.
- 3. The applicant must obtain a building permit prior to the commencement of work.
- 4. The applicant must obtain a separate sign permit for all proposed signage.
- 5. All employees must obtain parking permits.
- 6. Any conditions the Village Board and Village Attorney deem appropriate.
