The first one was received from Patricia Hoffman:

### Peter/George:

I do not believe the government should place a requirement of affordable housing in our code. If a developer can obtain and build units the Village should not require the builder to include affordable units. Of course then the issue comes up as to who monitors the award of the units. The code should support free enterprise and capitalism. We should not limit the ability of a developer for social programs. We already have affordable housing at the Woodlands, the proposed WaterWheel and the plans provided by Mr. Escaladas on 9A south of Colony Street.

Dear Barbara Berardi- AS YOU MAY KNOW I HAVE BEEN A MEMBER OF THE AFFORDABLE HOUSING COMMITTEE SINCE THE BEGINNING OF MAYOR Abate's final term. The proposed amendment is very well written and covers major areas of concern very well. I am in favor of it being approved. However, I believe that some requirement for less than five units be included which would require the developer to contribute a % of the sales price of the smaller housing development to an Affordable Housing Fund to be used by the village to purchase property for AH. In my view even a single unit home built in the village should make a contribution to the AH fund. Having attended a workshop on Affordable housing at Pace law school I know that some governments do have such a AH fund. Unfortunately, due to time constraints I am unable to provide specifics. Please forward my comments to the Trustees as well as other interested village personnel involved in this amendment draft. Thank you. James A. Chin, Sr.

### RESOLUTION MAYOR AND BOARD OF TRUSTEES VILLAGE OF ARDSLEY ACCEPTING AN UPDATED ZONING AND OFFICIAL MAP OF THE VILLAGE

**Trustee Nardecchia:** WHEREAS, the Village of Ardsley is a duly incorporated municipality in the State of New York governed by a Mayor and Board of Trustees (the Village Board); and WHEREAS, Section 7-702 of New York State Village Law provides the board of trustees with the authority to divide the Village into districts; and

WHEREAS, Section 7- 724 of New York State Village Law authorizes the Village Board to establish an official map of the Village showing the streets highways and parks; and

WHEREAS, as noted in the section 200-3.B. of the Village of Ardsley Zoning Code, the Village first adopted an official zoning map (the zoning map) on December 7, 1959; and

WHEREAS, over the course of the ensuring years, the Village has revised and updated the Zoning Map including the creation of new districts and streets; and

WHEREAS, the Village Board has kept records of the various zoning map revisions and is desirous of having all of the revisions consolidated in one updated map; and

WHEREAS, the updating of the existing Village zoning map is an ministerial action and is classified as a Type II action under Section 617.5 (c) (17) of the State Environmental Quality Review Act (SEQRA); and

NOW, THEREFORE, BE IT RESOLVED, that given the fact that the Village Board is the only duly authorized entity that may approve zoning and official map revisions it does declare themselves to be the Lead Agency for this proposed action; and be it further

RESOLVED, that the Village Board of the Village of Ardsley hereby does accept the revised Official Map of the Village of Ardsley; and be it further

RESOLVED, that the Village Board does hereby direct the Village Clerk to provide a copy of the updated Official Map dated October ,2012 to the Town of Greenburgh and the Westchester County Department of Planning. **Seconded by Trustee Malone and passed unanimously.**

### RESOLUTION REGARDING FREE HOLIDAY PARKING

**Trustee Malone: RESOLVED,** that the Village Board of the Village of Ardsley hereby authorizes the parking meter attendant to place bags over the municipal parking meters commencing on December 10, 2012 through January 2, 2013.

**BE IT FURTHER RESOLVED,** that although the use of coins in the meters is suspended, the posted time limits will be enforced by the Ardsley Police Department. **Seconded by Trustee Nardecchia and passed unanimously.**
