- 1. ANONYMOUS LETTERS: To all of our residents who send our offices anonymous letters, I thank you for your concern. Unfortunately, very few of these well-meaning letters can be acted on, and end up in the recycle bin. Without any contact information there is no means of securing additional vital details, or a means to respond to advise that the concern has been addressed. Any letters which show up that are criminal in nature, or threatening, are automatically forwarded to the Police Department for review and/or action. For those of you willing to provide your contact information for non-criminal matters, kindly address them to our Village Clerk's office. And for those of you who need to have something addressed of a criminal matter, you must visit the Police Department in person and file a formal written complaint.
- **2. CHARLES ENGELMAN:** In case anyone has noticed, the monument in honor of longtime merchant, Charles Engelman, is no longer located in the flowerbed between the Legion Park parking lot and the former Westchester Garage. And in response to at least one inquiry today, no, it has not been stolen. At the request of Mr. Engelman's son, Marty, and granddaughter, Sharon Colabello, the monument has been relocated to Pascone Park temporarily between the Honor Roll and the Legion building for safekeeping. Later this spring, the DPW will create a proper setting for the monument in the same vicinity. 2. Resolution granting permission to convert the vacant retail space at 721 Saw Mill River Road into a dine-in/take-out restaurant

8:30 P.M. – PUBLIC HEARING – To consider a change of use permit request from Wings on 9A, Inc., d/b/a Planet Wings into a combination restaurant retail establishment located at 721 Saw Mill River Road

Mayor Porcino read the notice into the record.

Mr. Anthony Federico, architect, appeared for the applicant and gave business plan details.

Mayor Porcino said for zoning purposes, this business is classified as a retail establishment. The building inspector has determined that twenty parking spaces are required, and there are fifty-six off street parking spaces available for the entire strip mall.

Mr. Tom Bennett, an owner, said the signage is small with red lettering and will blend in. They are going before the Board of Architectural Review on the proposed signage. He mentioned that their franchise agreement does not allow for double branding.

Mr. Bennett said that there will be an annual inspection on the cooking units to ensure Fire Code compliance. The hood will be steam cleaned twice a year.

The business will close on Sunday through Thursday at 10:30 p.m. and on Friday and Saturday at 11:30 p.m.

4. Resolution Authorizing Mayor to sign agreement with Sive, Paget & Riesel to provide legal counsel on Rivertowns Square Development

They hired legal counsel to determine if the Village should take any action.
