The Mayors' Monarch Pledge reporting was completed on December 1 for the 2022 cycle. Fourteen actions were completed, and, if accepted, this will place Ardsley in the Mayors' Monarch Leadership Circle.

# Proposed film screening: ArdsleyCAN & Pollinator Pathway Earth Day event teaming with Ardsley Parks & Rec

А wonderful Little Farm film for all ages, Biggest (https://www.biggestlittlefarmmovie.com/synopsis/slicencing), has potential film screening as Earth Month for а an event (https://www.biggestlittlefarmmovie.com/host-a-screening/). Suggested dates: May 6, rain date May 7 or April 29, rain date April 30. Key points:

- Outreach within Ardsley / AUFSD and across CACs in Rivertowns
- Engage 2-3 zero waste food vendors
- DPW to support compost collection
- Event to be marketed as pack in &pack out for waste reduction

Much discussion ensued. Key challenges are CAC and Parks and Rec resources and limited capacity at that time of year. An outdoor screening is preferred. Some of the brainstorming ideas of note:

- Beging with a late afternoon event to draw people in and, hopefully, they stay for the screening. Pre-events can include arts and crafts for kids (and look into hiring a professional for this role), information tables (e.g. pollinator pathway – perhaps even some seedlings or plugs made available)
- Venue was discussed at length. Indoors removes the weather challenge and means the movie can start earlier, however outdoors provides a nicer ambiance.
- Scope changes were also discussed. Perhaps the movie could be primarily for high school students with a Q&A/Discussion afterwards.
- Lorraine advised to book the date with Trish ASAP since it is a busy time of year and best to lock it in.
- In addition to resource constraints, the concern was getting people to show up. If held outdoors the movie could not start until later in the evening and we may lose people with younger children. A communication plan and outreach will be critical.
- Best not to use food trucks but to cater through a local vendor.
