<p style="text-align: center;"><b>MESSAGE FROM MAYOR JAY LEON</b></p> <p>They say that the “city never sleeps,” but neither does the Village of Ardsley – even in summer! Here are some items of interest that have taken place over the past few weeks:</p> <p><b><u>Lawrence Street Traffic Light</u></b> – The Village Board and TPPCS (traffic) Committee have been lobbying NYSDOT for over a year for a traffic light at Rt. 9A and Lawrence St. in the unincorporated area of Greenburgh. This intersection is a difficult one to traverse, and it will be a crucial detour during the Ashford Avenue Bridge reconstruction, scheduled to begin in about 18 months under the auspices of the County of Westchester. The light will make the intersection safer, and will move the increase in vehicles that will be using this route to avoid the bridge.</p> <p><b><u>The Ridge Hill Inter-Municipal Intersection Improvement Committee (RHIIIC)</u></b> - This is a rather awkward name for the committee that was assembled to oversee the \$5 million set aside as part of the Ridge Hill settlement. The committee has hired a traffic consultant, who will help sort out what can be done with intersections that will no doubt experience increased traffic when this mammoth project opens in Yonkers (construction is already underway – you can see it from the NYS Thruway across the street</p>	<p style="text-align: center;">*****</p> <p style="text-align: center;"><b>PERMIT NOW REQUIRED FOR ROOFING &amp; SIDING</b></p> <p>Until recently, building permits were not required in the village for roofing or siding work that did not affect the structural integrity of a building. However, due to recent changes in the New York State Building Code, we are now required to issue permits for all roofing and siding projects. If you are planning to install a new roof or siding on your house, it is the property owner's responsibility to obtain the necessary permits. Since it will take some time before all of the roofing and siding contractors who work in the village are made aware of this change, please inform your contractor of the need to file for a permit before signing a contract. The consultant has already begun taking traffic counts, and he will finish up after school begins and traffic returns to “normal.” The committee has representatives from Greenburgh, Hastings, and Ardsley. Trustee Peter Porcino and I serve as Ardsley's representatives.</p>	<p><b>CATV Notes</b> – As of this writing, the TV studio at village hall is being completely refurbished with state of the art broadcasting and audio-visual equipment. The Village Board Room is being equipped with new microphones, cameras and presentation hardware, which should require fewer volunteers to man the studio during broadcasts.</p> <p>Verizon has notified us that their FIOS service will soon be televising the Ardsley Government Channel 24/7, as well as the Greenburgh Government Channel and an Ardsley Education Channel, which will also reach non-Ardsley residents within the school district. Cablevision will broadcast the Education Channel when the school district is ready to begin broadcasts. We are also working with Verizon to hook up links from remote locations that will give us for the first time the capability of televising live events from the Library Meeting Room, the Community Center and McDowell Park.</p> <p>Please note that we have been advised by Cablevision that they will no longer be offering the government and educational channels as part of their basic (analog) service. Customers will need to subscribe to digital service in order to continue to receive our broadcasts. Cablevision has also informed us that they increased the number of HD channels they offer their digital customers, which are offered those customers at no extra charge.</p>

**Library Renovations:** The Ardsley Village Board has awarded a bid to Larchmont-based St. Francis Construction Company in the amount of \$1.3 million to renovate and expand the Ardsley Public Library building. The improvements and space are sorely needed; the renovation will add 2,200 square feet to the existing 6,120 square foot building, which is important for a library that serves the Village of Ardsley, the Village of Elmsford, and many residents of unincorporated Greenburgh Town. The project is to be financed by current and future library revenues.

**Waterwheel Property:** After an article appeared in The Journal News concerning the Town of Greenburgh's Request for Proposals (RFP) to purchase and develop the former site of the Waterwheel Restaurant for all or some affordable housing, almost thirty inquiries were posted with the Town's Planning Commissioner. The deadline for proposals was August 18. Representatives from the Town and Village Boards and their respective Affordable Housing Committees will work to choose the plan that best satisfies everyone's requirements. The Ardsley Affordable Housing Committee will also include representatives of the Stonegate Homeowners Association, the neighborhood located next door to the parcel on Revolutionary Road.

At this time, I'd like to extend my gratitude to our village employees and volunteers for their hard and diligent work throughout the year. Whether they work as police officers, fire fighters, highway workers, library, recreation, building, justice, finance or office/administration staff, our employees and volunteers do a great job day in and day out. If you have a chance, thank a village employee or volunteer! Don't forget the independent ambulance

volunteers as well. To close, please permit me to remind everyone that school is back in session, so drive carefully and have a successful and safe school year. – **Jay S. Leon, Mayor**

#### **YOUTH ADVOCATE PROGRAM NEWS**

The Ardsley Youth Advocate Program is starting the Safe Rides program for the village in the fall. Safe Rides is a student/adult-run organization that provides a safe and secure way for students to get home at night on the weekends. On designated weekend evenings, from 10:00 pm to 2:00 am, four to six students and one to two adult volunteers will staff the Safe Rides Program at the Ardsley Community Center. Two students working at the Community Center will answer all incoming telephone calls, log in calls and maintain contact via cellular phone and/or radios with each of the Safe Rides cars out on call. Two other students, preferably a male and a female, will be sent from the community center to pick up students as a team. The driver will use his or her family car and must have their senior license. The rider is responsible for keeping contact with the Community Center to give information on departure times, pick up times, addresses and passenger names.

The parents will be in a separate room from students taking calls. The parents are there to handle emergency situations only. Students participating in the Safe Rides program agree to keep all details of their service activities confidential within the program. An adult volunteer is on duty as a consultant if the young people need help. If any further assistance is desired, the team may contact the Safe Rides adult volunteers on duty, the police department, or the emergency ambulance service. All student and adult volunteers will receive training. We are looking

#### **STORMWATER NEWS: MUDDY WATERS**

No, we're not singin' the blues. That is unless your backyard construction project is washing dirt into the street with every rainstorm. The Village has had an Erosion and Sedimentation Control (ESC) Law on the books since 2005. NYSDEC is requiring an update of that Law to ensure certification of

SWPPP's (Stormwater Pollution Prevention Plans). Just to check up, you need a SWPPP if your project exceeds one acre, is a teardown of any size, is new construction of any size on a previously undeveloped lot or is part of a multi-unit development project. Make sure your contractor is in compliance.

Last tip of the summer – please don't over-water. We've had plenty of rain. Turn off that automatic sprinkler timer and check that your watering pattern doesn't include the street or driveway.

Fall is coming. Place those leaves in biodegradable bags, and keep our storm drains clear. Thanks for making our water cleaner! -- **Lorraine Kuhn, SWM Asst.**

#### **VILLAGE CLERK NEWS**

##### **DOG TALES:**

A "New Owner" License is required any time dog ownership is

changed. A new owner is required to pay the license fee regardless of the amount of time left on the previous license. Furthermore, NYS stipulates a new owner transaction takes place even if a change is done within the same household, such as from husband to wife, or parent to child.

##### **RABIES:**

You **CANNOT**, by law, have a license validated without current rabies information. The owner **CANNOT** have the license issued and bring back the new rabies info later.

##### **REPLACEMENT TAGS:**

Effective immediately, the replacement tag fee has been increased from \$2.00 to \$3.00.

##### **VITAL RECORDS:**

As your local Registrar of Vital Statistics and Village Clerk, the Village Clerk is responsible for the complete registration of all births and deaths occurring in the Village of Ardsley. Vital statistics are not public records, and availability is restricted. You may obtain a record by providing the specified identification and meeting the requirements.

**Birth Certificates:** Copies of birth certificates are only available to the person named on the certificate (18 years or older), the person's parents, a lawful representative, or anyone who presents a court order.

If you were born within the village limits of Ardsley, you may obtain a certified copy of your birth certificate.

**To apply in person:** Bring the appropriate identification for the type of certificate you are requesting, along with a \$10.00 fee (either cash or check payable to the Village of Ardsley), and a completed application which will be provided when you come in to the office.

**To apply by U.S. Mail:** Enclose a photocopy of the appropriate identification one of the following is required: a current driver's license, a DMV non-driver's license identification card, a valid U.S. Passport, or U.S. Military ID. Two (2) different utility bills of the applicant accompanied by a notarized letter are also acceptable.

**Death Certificates:** If the decedent died in the Village of Ardsley, the record is on file in our office. Death Records are available to the spouse by providing a driver's license or non-drivers ID and a certified copy of the marriage license. A parent can obtain a copy of a death record with a driver's license or non-drivers ID, and a certified birth certificate naming the parent.

#### **CALVI ON PASCONE**

"What can you say about a guy:  
- who has more knowledge about public works in his pinkie than I have been able to absorb in my entire career?

- who took his first vacation day in thirty years just two weeks ago, and then advised me he'd seen enough of the outside world?

- who is able to accomplish certain public works tasks that a barrel full of Village Managers could never accomplish in a hundred years?

- who stops by his office and even answers telephone calls on holidays and weekends because he knows some resident will have need of his services?

- who knows where all the sewer and water connections are located at the drop of a hat probably because he was on the job when the lines were first installed 40 and 50 years ago?

- who is known by ¾ of the Village's residents on a first name basis?

Louie Pascone is one of the most resourceful men that I have known in any field. No matter how tight funding gets from time to time he always manages to squeeze the most out of what he is allotted, and gets the job done. Louie is one of the last of a dying breed of dedicated municipal workers who strive to complete a task, and do it well, despite the fact that the clock indicates it's getting late. Louie is also one of Ardsley's unsung diplomats. Often when there is a dispute between neighbors or someone is feeling displeased about a Village service, and I send Louie to address the problem, nine times out of ten Louie reports back, "Hey George, you know that problem with so and so, it's all taken care of. Everyone's happy!" And that seems to be the secret of Louie's success, he's does his darnedest to try and make everyone happy. And everyone loves him in return.

On the question of retirement: From time to time Louie hints that he may retire, and I always abruptly cut him off self-servingly advising him that he isn't allowed to retire . . . at least until I'm out of

here! After so many years with the Village, would Louie survive retirement? Of course, I already told you he's very resourceful! The bigger question is, would Ardsley survive Louie's retirement? That remains to be seen! No doubt the Village will continue to exist, but will it be the same? Oft times I've heard that, with rare exception, no one's irreplaceable. I dare say, however, that rare exception may be Louie Pascone, and God bless his successor who has to fill some very big shoes."

#### **THE ARDSLEY MYSTIQUE REVISITED**

*Back in August 1999, I wrote an article for the Ardsley Villager called "The Ardsley Mystique." It centered on all the confusion generated by the little seven letter word that represents our community. I stumbled across the old story recently while mining my archives for a topic for this newsletter and decided to reprint it a) because I thought it might prove useful to the many people who have moved into the Village in the ensuing nine years, and b) to illustrate much hasn't changed which isn't necessarily a bad thing!*

"The word "Ardsley" means many things to many people. Unfortunately, much of it is erroneous and sometimes downright inconvenient. Woe to the unknowing traveler who takes a late train from Grand Central Station to Ardsley (as it appears on the schedule) only to arrive several miles away from the Village in the

tiny postal district of Ardsley-on-Hudson, which is located within the confines of the Village of Irvington. Woe to the poor truck driver from upstate who straggles into Ardsley Village Hall desperately seeking directions to a business on Ardsley Avenue which is, again, in Irvington or a home on Ardsley Road in Greenburgh which is disguised with a Scarsdale address.

The misconceptions about Ardsley are legion, and the zip code is the demon. Although it may have an Ardsley address, the old Ciba Geigy campus, which has metamorphosed into Ardsley Park, is not in the Village of Ardsley. Neither are Ardsley Estates, Ardsley Green, the Ardsley Middle School, the Ardsley Country Club, the Ardsley Swim & Tennis Club, or even the Ardsley Chiropractor's office.

Nobody calls anything by its right name. Ashford Park is not the Middle School field. McDowell Park is not Little League Field Park. Addyman Square is not Ardsley Square as the bus system would have you believe. Sometimes misconceptions are self-fulfilling prophecies. For years, many referred to the old Village Hall as the Fire House because they saw the apparatus bays on the first floor. Today, the old Village Hall is the Fire House ever since the municipal offices moved next door last August.

No one seems to know where the Village begins and ends otherwise we wouldn't be fielding complaints about Lawrence Street, Sheldon Street, Maple Street, Winding Road, Pine Street, or Wood Avenue all under the jurisdiction of our Greenburgh Town Supervisor. Cross Road between Markwood Avenue and Sprain Road is in the Town though OLPH's rectory is in the Village. Incidentally, there is only one home on the entire stretch of Sprain Road that is in the Village of Ardsley.

Speaking of Greenburgh, Edgemont is neither a Village nor any municipally recognized unit, nor is Hartsdale. They are merely neighborhoods which some like to reference by the quaint sobriquet "hamlets." Another widely held belief is that because we pay taxes to the Town of Greenburgh we also have the right to use Anthony Veteran Park's pool. Right? Wrong! On average, only three percent of a Village resident's tax bill is paid to the Town of Greenburgh. This three percent provides for the collections of Town, School, and County taxes, the handling of November general elections by the Town Clerk's office, assessment services, and the provision of traffic signs and road markings by the Town Highway Department. That's it! The taxes which are collected for the operation and maintenance of Greenburgh's parks are contained in what is known as the B Budget which is financed solely by the inhabitants of the Town of Greenburgh OUTSIDE the Villages, i.e. Hartsdale, Edgemont, Fairview, Parkway Homes, Chauncey, Ardsley Estates, Greenville, Boulder Ridge, Hidden Glen, St. Andrews, Donald Park, and lastly Clarewood.

Often we receive telephone calls at Village Hall asking us can't we do something about this school issue or another? The simple answer is no. Although we have an extremely friendly and cooperative working relationship with the school district we have absolutely no control over its operation. The Ardsley Union Free School District is a separate, independent, corporate entity operating under the auspices of the State Education Department. They do not even have to seek a building permit from us if they wish to expand a building. They are also much bigger than us, not only in budget, but in physical size as well. Ardsley Village has about 1400 households. The School District

has well over 3000 and includes homes in Dobbs Ferry, and the White Plains, Scarsdale, and Hartsdale postal districts of Greenburgh.

The Village of Ardsley has very little if any control over Saw Mill River Road. Also known as Route 9A, it is a road owned and operated by the New York State Department of Transportation. Macy Park is not a Village park. It is a park owned by the County of Westchester and operated by the County Department of Parks & Recreation.

Lastly, it is most important to dispel the myth that we have paid fire fighters and ambulance workers. They are all unsalaried and belong either to Ardsley Volunteer Engine Company No. 1 or to Ardsley Secor Volunteer Ambulance Corps. Also falling into the unpaid category are all the advisory boards and committees.

I trust this has been an eye opener for some, and not too confusing for others. If you're a new resident, give yourself some time to sort it all out. It's merely all part of the Ardsley mystique that makes this community so unique . . . and I wouldn't change a thing!"

***That was 1999, and here we are in 2008. So, what has changed in nine years? We have a new firehouse, and a new wing to the library underway. ASVAC gave us a new ambulance building. We dedicated Fire Fighter Park. The State redid Ashford Avenue and installed a new traffic light on Route 9A at Heatherdell Road. The County is redoing Macy Park, and will be redoing the Ashford Bridge in 2010. The County has decided to relocate storage for their voting machines and Public Safety Offices to Ardsley Park. Other than smaller improvements made to the various parks and other infrastructure, everything is pretty much the same. Ardsley is a fine community, a wonderful community, and remains a desirable community that many yearn to move into to raise their families. Of course, it has its***

*quirks. What community doesn't? However, its quirks are what makes this community interesting, and retain its unique mystique, the Ardsley Mystique! -- George F. Calvi, Village Manager*

### **THE POOPER SCOOPER LAW**

Word has reached our offices that dog walkers are not picking up after their pets. Please be advised that there is a local law prohibiting this action, and that observance of this law is not optional.

Section 190-10 of the Ardsley Village Code states that:

"No person owning, harboring, keeping or in charge of any dog shall cause, suffer, or allow such dog to soil, defile, defecate on, or commit any nuisance on any common thoroughfare sidewalk, passageway, bypath, play area, park, or any place where people

congregate or walk or upon any public property whatsoever or upon any private property without the permission of the owner of said property . . . The person who curbs a dog shall immediately remove all feces deposited by such by any sanitary method . . ."

Therefore, if you are the owner of a dog or in charge of one, please pick up after the pet. No one should have to experience the indignity of stepping into what dogs leave behind on front walks, driveways, or lawns. If a dog or dog owner is causing a nuisance in your neighborhood, please contact the Police Desk (693-1700) immediately. There is little the Police can do once the dogs and their walkers have departed. I thank you in advance for your cooperation in this matter. – **George F. Calvi, Village Manager**

### **MCCARTNEY / LEGION BUILDING SPIRITED TO ASHFORD PARK**

On June 16<sup>th</sup>, the Ardsley Village Board of Trustees approved a resolution to relocate the old American Legion / McCartney building from Dobbs Ferry to Ashford Park, in effect, saving an historic building that was slated for demolition.

Spearheading the effort to renovate the building is local engineer Paul Petretti who has valiantly secured pledges of assistance from many local contractors. Over the course of nearly a century, the building served as the headquarters of the McCartney Agency, the meeting place of the American Legion, and even for a short stint the offices of the Ardsley Village Clerk. For the last several decades it has been the garage of Dobbs Ferry resident and retired McCartney Agency employee, Joann DeRosa. Over the summer, Petretti gathered the faithful, in particular Ralph Denike

of Pat Paving, and the building was skillfully navigated down Lawrence Street, Saw Mill River Road, and Ashford Avenue on a flatbed from its temporary home at the Dobbs Ferry DPW garage and ultimately into a spot between the snack bar and the skateboard park in Ashford Park.

## NEWS BRIEFS

**HYDROGEN VEHICLE:** In its desire to support the design, improvement, and special testing of a special vehicle to save energy and enhance the environment, the Village Board on July 7<sup>th</sup> granted permission to Ardsley resident Gates Roberg-Clark to park his hydrogen-powered vehicle in Legion Park for 90 days. His vehicle is part of program sponsored by General Motors. In exchange, Mr. Roberg-Clark has been asked to provide the Village Board with a basic report on the use and operation of the vehicle upon the termination of the experiment. Take a look at the vehicle while it's still out there!

**ROAD IMAGING:** The Village of Ardsley has joined Greenburgh, Tarrytown, Elmsford, Hastings, and Dobbs Ferry in an imaging contract with a firm known as Transmap of

Columbus, Ohio. All of Ardsley's roads (except for state-owned Route 9A) were imaged this past summer. These images which will be set up on a Google Earth viewer, will become invaluable to our Highway Department staff in setting priorities for maintenance. The images will also be useful for the Village's storm water outfall program spearheaded by Lorraine Kuhn. Ardsley's share of the cost of this project was \$2,530.00

**RECYCLING:** Two large plastic blue containers were placed recently in Ashford Park and McDowall Park for use by the general public. It is hoped that these will be the first of several set up around the heavily pedestrian trafficked areas of the Village for bottles and cans particularly near bus stops. Thus far, the ones set up in the parks have proven to be very popular since the DPW has to

empty them often. The blue containers were the suggestion of the Environmental Action Committee chaired by Susan Porcino.

**ROAD RESURFACING:** In an attempt to rein in costs, the Village of Ardsley has joined Hastings and Greenburgh in releasing joint bids for road resurfacing this autumn. With the rapidly spiraling cost of oil-based products like asphalt, the three communities agreed this was the best possible way to work within their respective budgets and preserve the annual road resurfacing programs. Greenburgh is expected to open the bid results sometime in mid-September.
