## LIBRARY FINES INCREASED

On June 1, 1991, the Ardsley Public Library raised the fines for overdue materials. The new fine structure only affects adult materials, as follows: books, tapes, and music cassettes will be charged .10/day, up to a \$3.00 maximum per item. Fines for children's materials will remain at .05/day up to a \$1.50 maximum per item. The fine for overdue videocassettes shall remain at \$2.00/day per cassette.

## LEAF BAG PROGRAM: BUDGET CUT VICTIM

Village residents will no longer be able to obtain free leaf bags or purchase additional bags once supplied by the Village Clerk's office. The program was cut during the budget process as a cost savings measure.

## YOUTH ADVOCATE PROGRAM TEMPORARILY RESTORED

The Youth Advocate program, which was also a victim of budget cuts, has been temporarily resurrected. In June, the Village Board and the Ardsley Youth Committee approved a proposal from Marvin Cohen, Program Director of White Plains-based Cage Teen Center to reinstate the Youth Advocate program, at no cost to the Village, through December 1991. The six month reprieve would permit the Village Board to assess the final version and impact of the New York State budget, and most importantly afford the Youth Advocate an opportunity to handle and not abruptly remove service to sixteen active cases.

law on the books. Dog owners must keep their pets from soiling public areas such as sidewalks and parks, and particularly upon private property without the permission of the owner of said property. Any feces dropped on public property shall immediately be disposed of in a sanitary manner by the dog owner.

Residents are also reminded that they are responsible for preventing the disturbing noise which results from the continual barking of a dog. Anyone violating these laws may face fines between \$25.00 and \$250.00 for each infraction.

#### **RECYCLING REMINDERS**

Recycling Liaison, Trustee Linda Pohlmann reminds you that newspapers are placed curbside in "blue boxes" on the 2nd and 4th Wednesdays of the month, and that commingled recyclables are placed in "green boxes"

on the 1st and 3rd Wednesdays of the month. Regarding glass containers, only unbroken clear, green, or brown glass may be collected. [Please rinse the container, and remove the label and Regarding metal containers, lid.] uncrushed juice, food, and beverage containers may be included as well as their metallic lids. Any plastic container may be included which has the PETE or HDPE symbol on its bottom. These symbols can generally be found on milk, soda, spring water, and liquid laundry detergent containers. The cooperation of all Village residents is strongly urged. **Recycling not only** removes items from the wastestream, but helps protect the environment.
