The change is the result of the initiation of computerization at Village Hall and the recommendation of our new Village Manager, George Calvi. Since the last Village Bulletin, your Board of Trustees enacted an alarm law requiring that all burglar and fire alarm systems be registered with the Police Department annually and promulgating penalties for false alarms exceeding two in any calendar year. If you have not registered your existing alarm system or plan on installing one, please contact the Ardsley Police Department at 693-1700 for the appropriate form. There is no fee for registration, however, there are penalties for noncompliance.

#### **SUMMER ROAD PAVING SCHEDULE**

The annual summer road paving schedule has been finalized. Work is expected to commence August 6. Residents whose homes will be affected by the road paving will be advised a few days in advance by leaflets distributed by Highway Department personnel. It is expected that all work will be completed in 7 to 10 days. Listed below are the roads scheduled for repaving in August:

- a) Plainview Avenue from the Village Line to Eastern Drive;
- b) King Street in its entirety;
- c) Captain Honeywell Road from Powderhorn to Chimney Pot Lane;
- d) Highland Drive from Heatherdell Road to Beacon Hill Road;
- e) Concord Road from Heatherdell Road to Revere Road;
- f) Revere Road from Victoria to Concord Road;
- g) Morningside Road from Concord Road to Victoria;
- h) Oak Hill Road from Huntley Drive to Village Line;
- i) Huntley Drive South from Heatherdell Road to cul-de-sac;
- j) Euclid Avenue from Village Line north by 255 ft.

#### NOXIOUS WEEDS AND GROWTH ALONG VILLAGE RIGHT-OF-WAY

To avoid injury to pedestrians, residents are reminded to prevent hedges, tree limbs, and vegetation from growing into the Village right-of-way. It is the responsibility of each homeowner to maintain the right-of-way from their property line to the street. Grass must be no taller than six inches, and tree limbs and hedges must be not less than 9 feet above the roadway so as not to impede pedestrian traffic.

The Village Highway Department is responsible for tree maintenance where tree trunks and high limbs are over nine feet high. For further information, telephone Highway Foreman Louis Pascone at 693-0117, or Village Manager George Calvi at 693-1550.

# GARBAGE, RUBBISH, AND REFUSE CURBSIDE COLLECTION

Residents are reminded that all receptacles and other waste material, including bulk waste, shall be placed at the curb for collection <u>ONLY ON THE DAY OF COLLECTION</u> and empty receptacles <u>MUST BE REMOVED</u> from the curb within <u>TWELVE HOURS</u> following collection. Violators of this section of the Village Code are subject to fines

of not more than \$25 for each offense. In addition, residents, who miss the regular Wednesday newspaper recycling collections, are strongly urged not to abandon their blue boxes at curbside until the following pickup collection two weeks later.

#### RECYCLING UPDATE

The Village of Ardsley is researching the feasibility of implementing a commingled container recycling program. As proposed, residents would deposit in plastic boxes supplied by the Village brown, green, and clear glass containers as well as aluminum, tin, and other metal beverage and food containers. Glass and metal container collections in boxes (other than blue) would alternate Wednesdays with newspaper collections in the highly successful blue boxes. Many details still need to be ironed out, but it is hoped the new program can commence in November.

# FLOOD CONTROL PROJECT UPDATE

The flood control project coordinated by the Army Corps of Engineers has been completed for several months. Since the project's completion not one business, residence, or even basement in the central business district has been inundated by flood waters. However, some problems continue to plague the merchants of the Village Green. Due to the low elevation of the parking lot, the location of major storm drain outlets, the Corps' design of the parking lot as a ponding area, and the unusual amount of precipitation these past three months, patrons of the Village Green shops periodically have had to seek parking elsewhere. In response to this problem, the Village lobbied and won a concession from the New York State Department of Environmental Conservation to install two permanent submersible pump stations near the flood wall, or alternatively, the raising of a portion of the parking lot combined with the acquisition of a portable pump to compensate for the removal of ponding volume. A meeting is planned in the near future for key state and village officials so that selection and implementation of one of the two alternates may be accomplished by autumn.
