*A Message From Your Village Board*

*Dear Residents,*

*With the coming of Spring, residents are reminded that our noise ordinance limits the use of power gardening equipment to the following hours:*

*8:00 A.M. to 8:00 P.M. Weekdays and Saturdays  
10:00 A.M. to 8:00 P.M. Sundays and Holidays*

*Our recently enacted alarm law requires the registration of any police, fire or medical emergency alarm with the police department.*

*We thank our residents for supporting our mandatory recycling law. Over \$10,000 was saved in 1989 from newspaper recycling alone. The "blue box" program has tripled newspaper recycling.*

*Because the purchase of specialized recycling equipment is costly, the Board is awaiting the construction of the county-owned Material Recycling Facility (MRF) before embarking on additional mandatory recycling programs (as required by September 1992 under State Law). The MRF will allow the collection of commingled glass, aluminum and plastic in the same vehicle.*

*In the interim, the village will continue to recycle appliances, leaves and other yard waste. Recycling saves our environment and tax dollars.*

*A Reminder - Our lighted tennis courts reopen for the season  
March 31st!*

## VILLAGE ELECTIONS

Village elections will be held on March 20, 1990, for the offices of Village Justice and two trustees. In order to exercise our voting rights, we must meet certain requirements and conform with specified procedures. Please make careful note of the requirements and dates listed in the following, so that you may meet the necessary conditions and cast your ballot for the candidate of your choice.

### Voter Qualifications - To qualify as a voter:

1. You must be a United States Citizen.
2. You must be 18 years of age or older by March 20, 1990
3. You must have been a resident of the Village of Ardsley for the 30 days next preceding the election.

### Polling Places

1. Municipal Building - For 24th and 53rd Districts.

24th District - area South of Ashford Avenue.

53rd District - area on North side of Ashford Avenue including all streets running North from Ashford Avenue or accessible North from Ashford Avenue up to and including the Northern end of Kensington Road and Abington Avenue to that point.

2. Episcopal Church (located at intersection of Heatherdell Road and Revolutionary Road) - For 25th and 54th Districts.

54th District - area from Abington Avenue from the North side of the Northern intersection with Kensington Road to the South side of Heatherdell Road and the area South of Heatherdell Road or accessible South from Heatherdell.

25th District - area North of Heatherdell Road.

VILLAGE ORGANIZATION: The Board of Trustees will make appointments to all Village agencies, boards and committees at the Organizational Meeting on Monday, April 2, 1990. Although most of the membership of these Village agencies are reappointed, vacancies do occur. Our residents are urged to review the following list of Village agencies. #### At The Library

The Ardsley Public Library has started a Homebound Service. Anyone in the village who wants books picked up and delivered to their homes because of illness or other disability are encouraged to register for this service by calling 693-6636. Requests can be made by telephone and materials will be delivered on Monday afternoons. The library continues to add periodicals, audio-books and video titles. Come in and check it out.

#### Tax Bills

Village tax bills will be sent in late May. Two things residents should keep in mind:

1. If your mortgage has been satisfied, you should check with the Village Treasurer to insure that the bill is mailed to you. Your bank is responsible for notifying the Village but they sometimes forget. Residents are responsible for late charges even if you do not receive a bill under State Law.
2. The Village Board is considering increasing the sliding scale exemption for senior citizens. The proposed scale including income limits is:

### Important Notice About Recycling

-From the ACE Recycling Committee-

Since the village passed a mandatory recycling local law last June, the regular curbside collection of newspapers in blue boxes has been a highly successful method for implementing the new law. Due to this success, papers will no longer be accepted at the voluntary recycling depot in the municipal building parking lot after April 28th.

However, glass and aluminum will continue to be taken at the center until such time the village will be able to expand the present recycling operation of newspaper collection to include glass and aluminum.

Recycling hours at the volunteer center remain, as usual. Saturdays 10:00 A.M. - noon. To remind you:-

1. Proper preparation of glass includes rinsing bottles, removing rings and caps, and separating by color: clear, green, brown.
2. Please, do not drop off recyclables except on Saturday 10:00 A.M. - noon.
