1. PLEDGE OF ALLEGIANCE 8:04 P.M. CALL TO ORDER

2. POLICE ACADEMY CEREMONY

2.1 Chief Piccolino presented the following Police Awards:

PO Victor Bonadonna Meritorious Police Duty

On April 14th 2020 at approximately 9:47 am Sgt. Watson and PO Bonadonna were dispatched to the lake at Hunger Park off the Saw Mill River Parkway northbound for

a vehicle that had entered the water. Once officers arrived a female was observed in the driver's seat of that vehicle. The vehicle was approximately 200 feet from the shoreline. PO Bonadonna entered the water as the vehicle began to sink. Sgt. Watson remained on shore for radio communication, and also as a life line to PO Bonadonna. Westchester County Police arrived shortly after and entered the water as well. PO Bonadonna assisted with freeing the female victim from her vehicle, and made sure there were no other people inside the vehicle. The female was safely brought to shore by officers and was transported to a nearby hospital for treatment. Due to PO Bonadonna's heroic actions that morning I would like to award him with the Meritorious Police Duty Award.

PO Brian Roemer Exceptional Merit

On September 1st 2021 at approximately 10:00pm Sgt. Tarantino and PO Roemer were dispatched during Hurricane Ida to the area of Cross road for a female trapped in a vehicle. The caller stated that her mother's vehicle was washed off the roadway by floodwaters and she was unsure of where the vehicle was since it was dragged from its last known location. Further information was given by the caller that the vehicle was flipped upside down by the rushing water and was on its roof with water quickly rising inside the vehicle. PO Roemer rushed to the area where the vehicle was last reported and was able to locate it upside down in a wooded area with raging flood waters. PO Roemer and Fire Department members were able to tie off to heavy machinery and swim through the water to the vehicle. The victim was pulled out underwater through a rear window, and then was safely helped back to land. The victim was transported to the hospital where she made a full recovery. For his courageous and heroic actions, I would like to award Officer Brian Roemer with one of the departments highest honors the Exceptional Merit Award

Lt. Carl Calabrese Exceptional Merit Sgt. Daniel Watson Exceptional Merit

On December 2nd 2017 at approximately 2:29pm, Lt. Calabrese and Sgt. Watson were dispatched to a domestic disturbance. The caller stated she observed her husband entering their home with a gasoline can, and he was preparing to set fire to the house. Upon entering the home patrol observed gasoline covering the floor. As patrol entered the kitchen area the suspect was observed standing by the kitchen gas stove with one of the burners lit. The suspect attempted to reach for another knob on the stove to ignite a second flame. As the suspect attempted to do so both officers rushed to subdue the suspect before the home went up in flames. While fighting and trying to handcuff the suspect two large knives were observed protruding from his jacket. Officers were finally able to contain the suspect, secure the knives, and shut off the burners on the stove. Further investigation revealed that there was a tenant upstairs at the time that could have been a victim of the arson. Do to the officers fast and heroic actions no one was hurt, and lives may have been saved. As a result of these actions I would like to award Lt. Calabrese and Sgt. Watson with one of our highest awards of Exceptional Meri

On February 16th 2019 at approximately 1:27am, following a short term investigation by the Ardsley Police Department Detective Division and members of the Greenburgh Drug and Alcohol Task Force, a vehicle and traffic stop in the Ardsley Acres Motel led to the arrest of (3) male suspects for criminal possession of a weapon 2nd degree. A loaded .40 caliber handgun was located within the vehicle. Due to the quick actions taken by Det. Sgt. Tarantino and Det. Perkins to assemble a team and have all proper information available for the officers involved, no one was hurt that morning. A loaded handgun was taken off the streets that was readily capable of taking someone's life. It is due to their fine work on this case that I would like to present Det. Sgt. Tarantino and Det. Perkins with Unit Citation awards

Sgt. David Piccolino Unit Citation

On November 7th 2020 at 10:45AM, Sgt. Piccolino was dispatched to a jewelry store in the village, for a report of a robbery that had just occurred. Dispatch was notified that an off duty NYPD Officer was in the parking where the robbery occurred and decided to follow the suspect's getaway vehicle. Information was relayed to Sgt. Piccolino and he was able to catch up and locate the suspect's vehicle. After a vehicle, pursuit on the Saw Mill River Parkway the suspect's vehicle was finally stopped and Sgt. Piccolino executed a felony stop and arrest. The license plate on the vehicle was stolen and proceeds from the crime were located in the vehicle. With Sgt. Piccolino's quick response and concern for everyone's safety no one was hurt during this incident. The suspect was arrested and the owner of the store was able to have her stolen items returned. For his quick thinking and response, I would like to present Sgt. Piccolino with the Unit Citation

Sgt. David Piccolino: Life Saving Award PO Jonathan Goldstein: Life Saving Award

On December 14th 2021 at approximately 10:00am, Sgt. Piccolino and PO Goldstein were dispatched to a residence for a report of an unresponsive male. Sgt. Piccolino and PO Goldstein observed an unresponsive male face down on the basement bathroom floor. The male had labored breathing and would not respond to any stimulus. Both officers believed the male was experiencing an overdose, which could have been fatal if untreated. PO Goldstein administered a dose of Narcan and checked his vitals. It was determined the male needed an additional dose which was also administered by PO Goldstein. Approximately 2 minutes after receiving the second dose of Narcan the male subject began to regain consciousness. The male was then transported to the hospital for further treatment. It was later determined that the male had indeed overdosed on heroin. Due to the quick actions by both Sgt. Piccolino and PO Goldstein, the man involved made a full recovery and has a second chance at life. For their quick thinking and judgement, I would like to present Sgt. Piccolino and PO Goldstein with the Life Saving Award.

Sgt. Daniel Watson: Honorable Mention PO Brian Roemer: Honorable Mention

On June 3rd, 2019 at or about 6:00pm Intel was shared with the Village of Ardsley Police, Town of Greenburgh SWAT team, Greenburgh Drug Task Force, and Local FBI office that a murder suspect was staying at the Ardsley Acres Motel. All agencies involved quickly acted together to formulate a plan to take the suspect into custody with the safety of all involved being the priority. All personal were in place and prepared for a worst case scenario due to the fact they knew the suspect would be armed and others might be in the room with him. After the motel was evacuated police tried to make contact with the suspect. The suspect opened the motel door and engaged all officers on the scene with gunfire. A gun battle ensued between officers on the scene and the suspect. One SWAT member was shot during the incident and many other officers came very close to being struck by bullets. By the end of the incident the suspect was pronounced dead and the female in the room was taken into custody with no injuries. The officer who was shot made a full recovery and all other officers on the scene either sustained minor injuries or were not injured at all. Sgt. Fisher was a SWAT sniper who was in the woods ready to engage the suspect if the incident unfolded the way it did. Sgt. Fishers training and expertise as a SWAT sniper undoubtedly saved lives that night. Even as bullets were being shot at Sgt. Fisher, he demonstrated exceptional heroism in the performance of his duties. He placed his life in imminent risk with full knowledge of the risks involved, all above the call of duty. It is my honor to award Sgt. Fisher with the department's highest award the Medal of Honor.

I would also like to award Det. Sgt. Dan Tarantino and Det. Ron Perkins with a Unit Citation for all of their hard work assisting the agencies involved and providing communications and Intel throughout the entire incident. Sgt. Daniel Watson and PO Brian Roemer will receive the departments Honorable mentions for also assisting in the evacuation of civilians and traffic control as the incident unfolded. All members involved did an outstanding job in what might have been the Villages most violent incident. We are grateful to have such excellent, professional and selfless officers patrolling this village every day. I am proud of every one of them. Please let's give them all a round of applause to thank them.

6. WESTCHESTER POWER PAUSE PRESENTATION Dan Walsh-Sustainable Westchester

- 6.1 Mr. Walsh provided the Board with the 2022 Program Pause and MOU/Contracting Schedule.
 - Two attempts earlier this year to secure a new contract (a short-term extension) thwarted by volatility which saw the market move out of the "Price Not To Exceed" range set in those associated MOUs.

- As a consequence we were not able to maintain continuity in our contracts, and customers are being switched back to Con Edison supply in the interim.
- To avoid another such miss, the Participation MOU has been modified to use standard municipal "lowest responsible bidder" language.
- We want to answer any questions about this background or the pause schedule and support your deliberation on the MOU.

We have missed the window where a short-term extension might have had some benefit.

We are still working on the "sleeving" procurement model (allowing us to seek wholesale bids), but it will take more time to have this ready for execution.

Near-term pricing is particularly high and volatile, but now longer term contracts have started to look advantageous

So we are recommending that we solicit a 1-3 year contract per our normal practice in prior years.

- •We are targeting a fall resumption of the program; our schedule is based on a November 1 restart.
- Meeting this schedule requires we target bidding/award for around July 11 or 12th.
- •The MOUs are an integral part of the RFP process so we need them executed in hand before then to support the bidding.

A program notification mailing will go out to all participating customers after award per usual practice.

Upon securing a new electricity supply contract, each eligible community member who was in the program prior to the pause will receive a preenrollment letter, which:

- Notifies you of the program restart date
- •Describes the energy supply options, rates, and terms
- •Advises enrollees on the 30 day opt-out period for initial enrollment
- Provides more information and resources about the program

Your choices:

- •To enroll at the selected default, no action is needed
- •Opt-out using our online form on our website or through us by phone/email
- •To change supply selection, call/email us

As a note, if during the pause period you decide to sign an agreement with an ESCO for electricity supply, you would no longer be automatically enrolled back into Westchester Power.

- 2.a Village Manager Report June 20, 2022-Joe Cerretani Village Manager Joe Cerretani read the following report:
 - 1. TAXES DUE: The 1st half of the 2022 Village Tax is due, without penalty, by June 30th. Payments made in person after June 30th, or that arrive via mail postmarked by the postal service after June 30th, or arrive thereafter without a postmark, will be assessed a late penalty as required by the New York State Real Property Law. Meter-mailed postmarks are not a valid proof of timely payment. Most payments made through online banking come in without dates and will not be accepted if the envelope is not postmarked by the deadline. Please bear in mind that no Village official is empowered to waive the late fee for any reason.

Please note that the Village did mail out a second batch of bills on June 10 after receiving numerous reports that bills had not yet arrived that were mailed on May 31. We have received reports now that those original bills were received around June 17, but the replacement bills were received earlier that week. Please only pay one bill.

- 2. <u>UPDATE ON SEWER MAPPING PROJECT</u>: The mapping of the sanitary and storm sewer systems field work is completed and the consultant is working with staff to implement the software required for accessing and updating the details of the infrastructure. The Village is currently out to bid on closed circuit television inspection of sewer lines with a bid opening date of Friday, July 15. We hope to have a recommendation for a bid award at the August Regular Meeting.



Delta Variant: What We Know About the Science

On July 27, 2021, CDC released updated guidance on the need for urgently increasing COVID-19 vaccination coverage and a recommendation for everyone in areas of substantial or high transmission to wear a mask in public indoor places, even if they are fully vaccinated. CDC issued this new guidance due to several concerning developments and newly emerging data signals.

First, a significant increase in new cases reversed what had been a steady decline since January 2021. In the days leading up to our guidance update, CDC saw a rapid and alarming rise in the COVID-19 case and hospitalization rates around the country. In late June, the 7-day moving average of reported cases was around 12,000. On July 27, the 7-day moving average of cases reached over 60,000. This case rate looked more like the rate of cases we had seen before the vaccine was widely available.

Second, new data began to emerge that the Delta variant was more infectious and was leading to increased transmissibility when compared with other variants, even in some vaccinated individuals. This includes recently published data from CDC and our public health partners, unpublished surveillance data that will be publicly available in the coming weeks, information included in CDC's updated Science Brief on COVID-19 Vaccines and Vaccination, and ongoing outbreak investigations linked to the Delta variant.

Delta is currently the predominant variant of the virus in the United States. Below is a high-level summary of what CDC scientists have recently learned about the Delta variant. More information will be made available when more data are published or released in other formats.

Infections and Spread

The Delta variant causes more infections and spreads faster than early forms of SARS-CoV-2, the virus that causes COVID-19.

- The Delta variant is more contagious: The Delta variant is highly contagious, more than 2x as contagious as previous variants.
- Some data suggest the Delta variant might cause more severe illness than previous variants in unvaccinated people. In two different studies from

- Vaccination is the best way to protect yourself, your family, and your community. High vaccination coverage will reduce spread of the virus and help prevent new variants from
- Scotland, patients infected with the Delta variant were more likely to be hospitalized than patients infected with Alpha or the original virus that causes COVID-19. Even so, the vast majority of hospitalization and death caused by COVID-19 are in unvaccinated people.
- Unvaccinated people remain the greatest concern: The greatest risk of transmission is among unvaccinated people who are much more likely to get infected, and therefore transmit the virus. Fully vaccinated people get COVID-19 (known as breakthrough infections) less often than unvaccinated people. People infected with the Delta variant, including fully vaccinated people with symptomatic breakthrough infections, can transmit the virus to others. CDC is continuing to assess data on whether fully vaccinated people with asymptomatic breakthrough infections can transmit the virus.
- Fully vaccinated people with Delta variant breakthrough infections can spread the virus to others. However, vaccinated people appear to spread the virus for a shorter time: For prior variants, lower amounts of viral genetic material were found in samples taken from fully vaccinated people who had breakthrough infections than from unvaccinated people with COVID-19. For people infected with the Delta variant, similar amounts of viral genetic material have been found among both unvaccinated and fully vaccinated people. However, like prior variants, the amount of viral genetic material may go down faster in fully vaccinated people when compared to unvaccinated people. This means fully vaccinated people will likely spread the virus for less time than unvaccinated people.

Vaccines in the US are highly effective, including against the Delta variant.

- The COVID-19 vaccines approved or authorized in the United States are highly effective at preventing severe disease and death, including against the Delta variant. But they are not 100% effective, and some fully vaccinated people will become infected (called a breakthrough infection) and experience illness. For all people, the vaccine provides the best protection against serious illness and death.
- Vaccines are playing a crucial role in limiting spread of the virus and minimizing severe disease. Although vaccines are highly effective, they are not perfect, and there will be vaccine breakthrough infections. Millions of Americans are vaccinated, and that number is growing. This means that even though the risk of breakthrough infections is low, there will be thousands of fully vaccinated people who become infected and able to infect others, especially with the surging spread of the Delta variant. Low vaccination coverage in many communities is driving the current rapid surge in cases involving the Delta variant, which also increases the chances that even more

concerning variants could emerge.

• Vaccination is the best way to protect yourself, your family, and your community. High vaccination coverage will reduce spread of the virus and help prevent new variants from Omicron Variant: What You Need to Know Emergence of Omicron On November 24, 2021, a new variant of SARS-CoV-2, B.1.1.529, was reported to the World Health Organization (WHO). This new variant was first detected in

specimens collected on November 11, 2021 in Botswana and on November 14, 2021 in South Africa.

On November 26, 2021, WHO named the B.1.1.529 Omicron and classified it as a Variant of Concern (VOC). On November 30, 2021, the United States designated Omicron as a Variant of Concern, and on December 1, 2021 the first confirmed U.S. case of Omicron was identified.

CDC has been collaborating with global public health and industry partners to learn about Omicron, as we continue to monitor its course. CDC has been using genomic surveillance throughout the course of the pandemic to track variants of SARS-CoV-2, the virus that causes COVID-19, and inform public health practice. We don't yet know how easily it spreads, the severity of illness it causes, or how well available vaccines and medications work against it. Despite the increased attention of Omicron, Delta continues to be the main variant circulating in the United States.

Infection and Spread

- How easily does Omicron spread? The Omicron variant likely will spread more easily than the original SARS-CoV-2 virus and how easily Omicron spreads compared to Delta remains unknown. CDC expects that anyone with Omicron infection can spread the virus to others, even if they are vaccinated or don't have symptoms.
- Will Omicron cause more severe illness? More data are needed to know if Omicron infections, and especially reinfections and breakthrough infections in people who are fully vaccinated, cause more severe illness or death than infection with other variants.
- Will vaccines work against Omicron? Current vaccines are expected to protect against severe illness, hospitalizations, and deaths due to infection with the Omicron variant. However, breakthrough infections in people who are fully vaccinated are likely to occur. With other variants, like Delta, vaccines have remained effective at preventing severe illness, hospitalizations, and death. The recent emergence of Omicron further emphasizes the importance of vaccination and boosters.
- Will treatments work against Omicron? Scientists are working to determine how well existing treatments for COVID-19 work. Based on the changed genetic make-up of Omicron, some treatments are likely to remain effective while others may be less effective.

We have the Tools to Fight Omicron

Vaccines remain the best public health measure to protect people from COVID-19, slow transmission, and reduce the likelihood of new variants emerging. COVID-19 vaccines are highly effective at preventing severe illness, hospitalizations, and death. Scientists are currently investigating Omicron, including how protected fully vaccinated people will be against infection, hospitalization, and death. CDC recommends that everyone 5 years and older protect themselves from COVID-19 by getting fully vaccinated. CDC recommends that everyone ages 18 years and older should get a booster shot at least two months after their initial J&J/Janssen vaccine or six months after completing their primary COVID-19 vaccination series of Pfizer-BioNTech or Moderna.

Masks offer protection against all variants. CDC continues to recommend wearing a mask in public indoor settings in areas of substantial or high community transmission, regardless of vaccination status. CDC provides advice about masks for people who want to learn more about what type of mask is right for them depending on their circumstances.

Tests can tell you if you are currently infected with COVID-19. Two types of tests are used to test for current infection: nucleic acid amplification tests (NAATs) and antigen tests. NAAT and antigen tests can only tell you if you have a current infection. Individuals can use the COVID-19 Viral Testing Tool to help determine what kind of test to seek. Additional tests would be needed to determine if your infection was caused by

Omicron. Visit your state, tribal, local, or territorial health department's website to look for the latest local information on testing. Self-tests can be used at home or anywhere, are easy to use, and produce rapid results. If your self-test has a positive result, stay home or isolate for 10 days, wear a mask if you have contact with others, and call your healthcare provider. If you have any

questions about your self-test result, call your healthcare provider or public health department. Until we know more about the risk of Omicron, it is important to use all tools

available to protect yourself and others. What CDC is Doing to Learn about Omicron Virus Characteristics CDC scientists are working with partners to gather data and virus samples that can be studied to answer important questions about the Omicron variant. Scientific

experiments have already started. CDC will provide updates as soon as possible. Variant Surveillance

In the United States, CDC uses genomic surveillance to track variants of SARS-CoV-2, the virus that causes COVID-19 to more quickly identify and act upon these findings to best protect the public's health. CDC established multiple ways to connect and share genomic sequence data being produced by CDC, public health laboratories, and commercial diagnostic laboratories within publicly accessible databases maintained by the National Center for Biotechnology Information external icon (NCBI) and the Global Initiative on Sharing Avian Influenza Data external icon (GISAID). CDC's national genomic surveillance can detect a variant that is

circulating at 0.1% frequency with 99% statistical confidence.

What to do if you test positive for COVID-19

If you test positive for COVID-19 and have one or more health conditions that increase your risk of becoming very sick, treatment may be available. Contact a health professional right away after a positive test to determine if you may be eligible, even if your symptoms are mild right now. Don't delay: Treatment must be started within the first few days to be effective. If you have a fever, cough, or other symptoms, you might have COVID-19. Most people have mild illness and are able to recover at home.

If you are sick:

• Keep track of your symptoms.

- If you have an emergency warning sign (including trouble breathing), call 911. Steps to help prevent the spread of COVID-19 if you are sick If you are sick with COVID-19 or think you might have COVID-19, follow the steps below to care for yourself and to help protect other people in your home and community. Stay home except to get medical care. o Stay home. Most people with COVID-19 have mild illness and can recover at home without medical care. Do not leave your home, except to get medical care. Do not visit public areas and do not go to places
- o Take care of yourself. Get rest and stay hydrated. Take over-the counter medicines, such as acetaminophen, to help you feel better.
- o Stay in touch with your doctor. Call before you get medical care. Be sure to get care if you have trouble breathing, or have any other emergency warning signs, or if you think it is an emergency.
- o Avoid public transportation, ride-sharing, or taxis if possible.
- o If you have symptoms of COVID-19, get tested. While waiting for test results, stay away from others, including staying apart from those living in your household.
- o Get tested as soon as possible after your symptoms start. Treatments may be available for people with COVID-19 who are at risk for becoming very sick. Don't delay: Treatment must be started early to be effective—some treatments must begin within 5 days of your first symptoms.
- Supply of treatments may be limited, and treatments are reserved for those at high risk for becoming very sick. Contact your healthcare provider right away if your test result is positive to determine if you may be eligible.
- Self-tests are one of several options for testing for the virus that causes COVID-19 and may be more convenient than laboratory-based tests and point-of-care tests. Ask your healthcare provider or your local health department if you need help interpreting your test results.
- You can visit your state, tribal, local external icon, and territorial health

department's website to look for the latest local information on testing sites.

Separate yourself from other people As much as possible, stay in a specific room and away from other people and pets in your home. If possible, you should use a separate bathroom. If you need to be

around other people or animals in or outside of the home, wear a well-fitting mask. Tell your close contacts that they may have been exposed to COVID-19. An infected person can spread COVID-19 starting 48 hours (or 2 days) before the person has any symptoms or tests positive. By letting your close contacts know they may have been exposed to COVID-19, you are helping to protect everyone.

- Symptoms of COVID-19 include fever, cough, or other symptoms.
- Follow care instructions from your healthcare provider and local health department. Your local health authorities may give instructions on checking your symptoms and reporting information.

When to seek emergency medical attention

Look for emergency warning signs* for COVID-19. If someone is showing any of these signs, seek emergency medical care immediately:

- Trouble breathing
- Persistent pain or pressure in the chest
- · New confusion
- Inability to wake or stay awake
- Pale, gray, or blue-colored skin, lips, or nail beds, depending on skin tone
- *This list is not all possible symptoms. Please call your medical provider for any other symptoms that are severe or concerning to you.

Call 911 or call ahead to your local emergency facility: Notify the operator that you are seeking care for someone who has or may have COVID-19. mobile light icon

Call ahead before visiting your doctor

- Call ahead. Many medical visits for routine care are being postponed or done by phone or telemedicine.
- If you have a medical appointment that cannot be postponed, call your doctor's office, and tell them you have or may have COVID-19. This will help the office protect themselves and other patients.

If you are sick, wear a well-fitting mask

- You should wear a mask if you must be around other people or animals, including pets (even at home).
- Wear a mask with the best fit, protection, and comfort for you.
- You don't need to wear the mask if you are alone. If you can't put on a mask (because of trouble breathing, for example), cover your coughs and sneezes in some other way. Try to stay at least 6 feet away from other people. This will help protect the people around you.
- Masks should not be placed on young children under age 2 years, anyone who has trouble breathing, or anyone who is not able to remove the mask without help.

Cover your coughs and sneezes

- Cover your mouth and nose with a tissue when you cough or sneeze.
- Throw away used tissues in a lined trash can.
- Immediately wash your hands with soap and water for at least 20 seconds. If soap and water are not available, clean your hands with an alcohol-based hand sanitizer that contains at least 60% alcohol.

Clean your hands often

- Wash your hands often with soap and water for at least 20 seconds. This is especially important after blowing your nose, coughing, or sneezing; going to the bathroom; and before eating or preparing food.
- Use hand sanitizer if soap and water are not available. Use an alcohol-based hand sanitizer with at least 60% alcohol, covering all surfaces of your hands and rubbing them together until they feel dry.
- Soap and water are the best option, especially if hands are visibly dirty.
- Avoid touching your eyes, nose, and mouth with unwashed hands.
- Handwashing Tips

Avoid sharing personal household items

- Do not share dishes, drinking glasses, cups, eating utensils, towels, or bedding with other people in your home.
- Wash these items thoroughly after using them with soap and water or put in the dishwasher.

Clean surfaces in your home regularly

- Clean and disinfect high-touch surfaces (for example, doorknobs, tables, handles, light switches, and countertops) in your "sick room" and bathroom. In shared spaces, you should clean and disinfect surfaces and items after each use by the person who is ill.
- If you are sick and cannot clean, a caregiver or other person should only clean and disinfect the area around you (such as your bedroom and bathroom) on an as needed basis. Your caregiver/other person should wait as long as possible (at least several hours) and wear a mask before entering, cleaning, and disinfecting shared spaces that you use.
- Clean and disinfect areas that may have blood, stool, or body fluids on them.
- Use household cleaners and disinfectants. Clean visible dirty surfaces with household cleaners containing soap or detergent. Then, use a household disinfectant.
- o Use a product from EPA's List N: Disinfectants for Coronavirus (COVID-19)external icon
- o Be sure to follow the instructions on the label to ensure safe and effective use of the product. Many products recommend keeping the surface wet with a disinfectant for a certain period of time (look at "contact time" on the product label).
- o You may also need to wear personal protective equipment, such as

gloves, depending on the directions on the product label.

o Immediately after disinfecting, wash your hands with soap and water for 20 seconds.

(The deleted text is in strikethrough and the new text is underscored)

Article I Definitions

§109-1. Definitions

As used in this chapter, the following terms shall have the meanings indicated:

FILMING -When cameras and equipment are at a premises.

FILM POLICY - The Village of Ardsley Film Policy that is in effect at the time of filming.

Article II Private Property

§109-2. Filming on Private Property

No commercial, movie, documentary television program, similar presentation or any portion thereof shall be filmed, videotaped, recorded or otherwise made on any private property within the Village of Ardsley unless the owner or tenant in control of the property or the professional film company first makes an application to and obtains a permit from the Village of Ardsley.

§109-3. Applications for permit

Applications shall be obtained from and submitted for review to the Village Clerk as required by and enumerated in the Film Policy. in person or by mail at least five business days in advance of the filming and must contain at least the following information:

- A. The name, address and telephone number of the applicant.
- B. The location of the property where filming, etc., is to take place.
- G. State if the applicant is the owner or tenant in possession of the property or the filming company.
- D. The name and address of the owner of the property if the applicant is not the owner.
- E. The consent of the owner if other than the applicant.
- F. The name, address and telephone number of the person or entity the applicant wishes to allow to film, etc.
- G. The date filming is to take place and the hours of filming.
- H. The dates within the previous 12 months that any filming, as described in § 109-2 above, was conducted at this location.
- I. Affirmation that filming will not involve use of public property.
- J. A signed statement that the applicant affirms, under penalty of perjury, that all statements contained in the application are true.

K.

All other information requested on the application.

§109-4. Fee

Each applicant shall pay a fee to the Village of Ardsley in the amount as set forth in Schedule of FeesFilm Policy, for each permit.

§109-5. Operational Restrictions

A. Filming for which a permit is required under § 109-2 above shall be conducted in compliance with the Film Policy in no event be conducted at the same location (i.e., in the

same building or at the same street address) more than any portion of 12 calendar days within any twelve month period.

B. No applicant shall permit any filming for which a permit has been issued to be conducted prior to 7:00 a.m. or after 10:00 p.m.

C. No applicant shall permit equipment used in connection with such filming, including but not limited to lights, generators and related equipment, to be set up or operated at the location described in § 109–3 above prior to 7:00 a.m. or after 10:00 p.m.

§109-6. Penalties for offenses

A. Any person, persons, corporation, company, group or other entity of any kind who fails to obtain the permit required herein or otherwise violates any provision of this chapter shall be subject to a fine of up to \$250 or imprisonment for not more than 15 days, or both such fine and imprisonment.

B. The imposition of such penalty shall not be Village's exclusive remedy in the event of a violation of this chapter. The Village may pursue any and all other legal remedies available to it in connection with any violation of this chapter.

§109-7. Limitations for previous violations

Notwithstanding any of the foregoing, no applicant who has been previously convicted of a violation of this chapter shall be granted a permit hereunder for a period of 18 months from the date of such conviction.

ARTICLE III Public Property

§109-8 Filming on public property

No commercial, movie, documentary television program, similar presentation or any portion thereof shall be filmed, videotaped, recorded or otherwise made on any public property (streets, sidewalks, parks, etc.) within the Village of Ardsley, unless application is made and a permit obtained from the Village of Ardsley. This includes the running of cable, the placing or storing of equipment of any kind, the parking of vehicles, etc., on any public property or any other use of public property for the purpose of making films, etc. (NOTE: Specifically excluded are all filming projects conducted under the auspices of the Village of Ardsley Cable Television Committee.)

§109-9. Application for permit

Applications shall be obtained from and submitted to the Village Clerk <u>as required by and enumerated in the Film Policy.</u> in person or by mail at least 10 business days in advance of the filming and must contain at least the following information:

- (1)The name, address and telephone number of the person or company making the film, etc.
- (2) The location where filming, etc., is to take place.
- (3) The date filming is to take place and the hours of filming.
- (4) A signed statement that the applicant affirms, under penalty of perjury, that all statements contained in the application are true.

- (5) Approval from the Police Chief, with any conditions he may set forth.
- (6) Any other approval the Village Manager or Village Clerk deems necessary, with any conditions which may be set forth.
- B. A certificate of insurance must be submitted with the application, naming the Village of Ardsley as an additional insured, in amounts satisfactory to the Village.

§109-10 Fee

The fee for such permit shall be as set forth in the Schedule of Fees Film Policy.

§109-11 Operational Restrictions

A. Filming for which a permit is required under § 109-8 above shall be conducted in compliance with the Film Policy. No applicant shall permit any filming, etc., for which a permit has been issued to be conducted prior to 8:00 a.m. or after 7:00 p.m.

B. No applicant shall permit equipment used in connection with such filming, including but not limited to lights and generators, etc., to be set up or operated at the location described in § 109-9 above prior to 8:00 a.m. and after 7:00 p.m.

§109-12 Penalties for offenses

A. Any person, persons, corporation, company, group or other entity of any kind who fails to obtain the permit required herein or otherwise violates any provision of this chapter shall be subject to a fine of up to \$1,000\$5,000.

B. The imposition of such fine shall not be the Village's exclusive remedy in the event of a violation of this chapter. The Village may pursue any and all other legal remedies available to it in connection with any violation of this chapter.

§109-13 Limitations for previous violations

Notwithstanding any of the foregoing, no applicant who has been previously convicted of a violation of this chapter shall be granted a permit hereunder for a period of 18 months from the date of such conviction.

ARTICLE IV Film production schedule of fees

§109-14 Submission of requests

RESERVED

Requests for film productions which will exceed five days must be submitted to the Village Clerk in writing, at least 10 business days prior to filming, for his or her consideration and approval. Such approval may include fees and any conditions the Village Manager or Village Clerk may deem necessary and expedient.

§ 109-15 Fees.

All fees for each permit referred to herein are payable in the amounts designated in Chapter A210, Feesthe Film Policy

VILLAGE OF ARDSLEY FILM POLICY

- A permit is required to film, videotape, video record, or televise for commercial
 purposes on public or private property within the municipal boundaries of the Village of
 Ardsley. Non-profit and student films will be evaluated on a case-by-case basis to
 determine if a film permit is necessary.
- 2. The application to obtain a Filming Permit must be completed and submitted to the Village Clerk, including all required supporting documentation and applicable fees, at least fourteen (14) days prior to filming. Late applications are accepted at the discretion of the Village Clerk, and may be subject to a double fee.
- 3. The Village reserves the right to deny any permit hereunder if it is deemed not in the public interest.
- The Village must be named as additional insured on the liability policy of the producer or permittee (\$3,000,000 minimum) and proof of such coverage must be provided prior to filming.
- 5. The permittee shall execute an indemnification agreement holding the Village harmless and agreeing to indemnify the from any liability.
- 6. The Village must be provided evidence of appropriate Worker's Compensation Insurance that provides coverage for all members of the production.
- 7. The filming must comply with all Federal, State, and local laws and ordinances.
- 8. The Applicant will be required to post a cash bond or present a check made payable to the Village of Ardsley in an amount to be determined by the Village Clerk of no less than \$2,500 to insure compliance with regulations and representations of the production company.
- 9. A permit fee must be paid to the Village of Ardsley as follows:

All productions larger than a small production as defined below on public or private property \$5,000 per filming day.

Small productions as defined below on public or private property \$1,500 per filming day.

Small productions are productions which involve no more than:

- (1) one truck with a bed not to exceed 10 feet in length, 8,600 gross vehicle weight and 4 wheels parked in a location to be approved by the Chief of Police
- (2) no more than 2 passenger vehicles parked in a location to be approved by the Chief of Police;
- (3) no on-site generator;
- (4) no more than 15 cast and crew members

Non-profit/ Student filming: \$1,500 per filming day (as per Item 1, non-profit and student films may be exempt from fees) at the discretion of the Village Manager

- 10. A filming day shall be defined as 7:00am to 7:00pm. Irrespective of total duration of filming in a day, any filming outside of the filming day timeframe will incur additional costs of one-twelfth (1/12) the filming day rate per hour. Filming done entirely outside the hours of the regular filming day described above will still be subject to the full charge for a filming day in addition to pro-rated hourly charges. Furthermore, the day will be defined to begin when vehicles and equipment arrive and setting up begins, and the day will be defined to end when the area is restored and the last member of the production leaves the area.
- 11. Ardsley Police Officers must be used for traffic and crowd control. The stopping and redirecting of pedestrian and vehicular traffic may only be performed by Ardsley Police Department personnel, or designee of the Chief of Police. Police vehicles and equipment used will also be billed at hourly rates. All applicable Police fees are nonnegotiable and will be billed separately.
- 12. The Permittee will be responsible for and will be billed separately for all costs associated with the Department of Public Works as it relates to the production, including but not limited to special sanitation collection, street lighting, and site restoration work. Public Works vehicles and equipment used will also be billed at hourly rates. All applicable Public Works fees are non-negotiable and will be billed separately.
- 13. The parking and storing of all vehicles and equipment related to the production shall be confined to a location designated by only the Village Manager, Chief of Police, or designee. Parking and storing of vehicles and equipment may be charged an appropriate additional fee to be determined by the Village Manager.
- 14. The Permittee or designee must personally contact those residents and businesses affected by the filming schedule, in writing, no less than seven (7) days prior to filming. Residents and businesses must be provided an opportunity to ask questions to the film company about the impact of the production.
- 15. The Chief of Police and Village Manager, or designee have the power to immediately shut down filming if deemed in the interest of public interest or safety. Furthermore, the Village may also immediately revoke any permit upon discovery of false or misleading statements in the application or for violation of any terms of the permit.

16. Upon completion of the filming within the Village, the Applicant is responsible for restoring the area to its original condition.	
17. The application may be approved conditionally with special conditions set by the Village Manager, Chief of Police, or designee.	
18. Amendments to an approved permit must be approved separately and will be subject to an additional fee of \$500 to the Village.	
19. To receive a full refund, the Village must be given no less than 48 hours' notice to any cancellation of filming. If proper notice of cancellation is not received, the Applicant will not be refunded any portion of the permit cost.	
20. Outside and above any fees and charges applicable in this policy, there shall be an administrative fee of \$250 per film day for <u>each</u> service supplied by the Village, including but not limited to Police and Public Works, for the coordination of staff and any village resources used to accommodate filming and production needs. Productions that do not require municipal services will not be subject to this fee.

The Company agrees to perform all services set forth in and in accordance with the bid document entitled "Bid Specifications Facility Cleaning, Village of Ardsley, NY", which is annexed to and made a part of this Agreement as Exhibit A (the "Services").

Article 2. Term

The term of this agreement shall be in effect for a period of one year. The term XXXX, through XXXX. - C. THE COMPANY or any of its subcontractors are hereby prohibited from engaging in discriminatory hiring practices, or assuming any engagements during the term of this Agreement which might be in conflict with the Company's responsibilities under this Agreement.

Article 11. Termination

The Village may terminate this contract upon 30 days' written notice if the Company defaults on any terms and conditions herein and the Company fails to cure the default within the 30-day period.

Article 13: Alternative Provision



WHEREAS, the Village and Police Officer Keith Gannon and the Ardsley Policemen's Benevolent Association, Inc. ("PBA") engaged in discussions to resolve all pending litigation and issues/claims involving Mr. Gannon in connection with his June 28, 2022 retirement from employment with the Village;

NOW, THEREFORE, BE IT RESOLVED that the Village Board of Trustees hereby approves and ratifies the attached Stipulation of Agreement by and among the Village and Mr. Gannon and the PBA, as executed by Mr. Gannon on June 24, 2022, including all terms set forth therein.

STIPULATION OF AGREEMENT

WHEREAS, Keith Gannon ("Gannon") is presently employed as a Police Officer for the Village of Ardsley ("Village"); and

WHEREAS, the Village and the Ardsley Policemen's Benevolent Association, Inc. ("PBA") are parties to a collective bargaining agreement for the period June 1, 2019 through May 31, 2021 ("CBA"), and Gannon, as a bargaining unit member of the PBA, is subject to the terms and conditions thereof; and

WHEREAS, on or about July 13, 2017, Gannon injured his right knee while on duty and has been, since then, intermittently absent from work due to this injury, including consecutively since March 11, 2022; and

WHEREAS, Gannon's counsel has advised the Village that Gannon filed applications for both Performance of Duty and Accidental Disability retirements with the New York State Police & Fire Retirement System ("PFRS") in which he affirms that he is permanently disabled from the performance of his regular duties as a Police Officer; and

WHEREAS, the Village has been advised that Gannon's application for Accidental Disability Retirement has been initially denied; and

WHEREAS, Gannon's counsel has advised the Village that the PFRS has not yet rendered a determination with regard to Gannon's Performance of Duty Disability Retirement application; and

WHEREAS, Gannon has continued to assert that he is unable to perform the full duties of his position as a Police Officer; and

WHEREAS, Gannon has informed the Village that he seeks to retire because he remains physically unable to perform the full duties of his position as a Police Officer due to injuries he suffered in the performance of his duties,

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED as and for a Stipulation of Agreement ("Agreement") by and among the Village, Gannon, and the PBA (collectively, the "parties"):

1. In exchange for the consideration and promises in Paragraph 2 of this Agreement, Gannon hereby submits this Agreement as his irrevocable resignation for purposes of a regular/service retirement from all employment with the Village, effective no later than June 28, 2022.

Gannon hereby agrees to execute the attached resignation letter and submit it to the Village simultaneously with this Agreement.

- 2. The Village, in exchange for Gannon's irrevocable resignation for purposes of a regular/service retirement, agrees as follows:
 - a. Accepts Gannon's irrevocable resignation for purposes of a regular/service retirement, effective no later than June 28, 2022;
 - b. Agrees that in accordance with the applicable provisions of the CBA, Gannon will be eligible for health insurance in retirement as set forth in the CBA following the effective date of his irrevocable resignation for purposes of a regular/service retirement (June 28, 2022);
 - c. The Village acknowledges that Gannon is retiring because he is unable to perform the full duties of his position as a Police Officer due to injuries to his right knee, which he suffered in the performance of his duties as a Police Officer in 2017; and
 - d. If the New York State Workers' Compensation Board determines that any of Gannon's injuries were incurred in the course of his employment and Gannon receives any Workers' Compensation award, including wage reimbursement(s), for the period July 13, 2017 through the effective date of his irrevocable resignation for the purposes of a regular/service retirement, such payment(s) and/or award(s) by Workers' Compensation shall be paid directly to the Village.
- 3. Gannon hereby expressly waives and/or releases any and all rights and/or claims he has or may have ever had to General Municipal Law Section 207-c status and/or benefits ("Section 207-c") for any of the injuries and/or illnesses he alleges he suffered in the performance of his duties while employed by the Village, including all claims related to the on or about July 13, 2017 injury.

Gannon and the PBA agree to withdraw with prejudice the pending Section 207-c arbitration (PERB Case Number A2022-014) scheduled for a hearing on September 14, 2022. Gannon and the PBA agree to do so in writing, copy to Village counsel, within fourteen (14) calendar days of full execution of this Agreement.

- 4. Gannon acknowledges and agrees that the Village's promises set forth in Paragraph 2 above are sufficient and valuable consideration for his waiver of claims in Paragraphs 3 and 5 of this Agreement.
- 5. In exchange for the agreements and other promises made by the Village in Paragraph 2 of this Agreement, and in full and complete settlement of all claims that Gannon has or may have had whatsoever, asserted or unasserted, suspected or unsuspected with respect to his employment with the Village or any other interactions of any kind with the Village, Gannon hereby expressly waives any and all rights he may have or believes he may have had, now has or may hereinafter have, to bring or pursue any lawsuit, proceeding, grievance, arbitration, administrative charge or complaint upon

any claims Gannon may have or may have had against the Village and its current and former elected and appointed officials, employees, representatives and attorneys regarding any matter arising on or before the date of Gannon's execution of this Agreement, including, but not limited to, claims with respect to his employment with the Village and/or any other interactions with the Village. Gannon hereby irrevocably and unconditionally releases and forever discharges the Village of and from any actions, causes of action, suits, obligations, damages, liabilities, claims, grievances, arbitrations, costs, rights, expenses and/or any controversies in law or equity of any nature whatsoever asserted or unasserted, known or unknown, suspected or unsuspected, which Gannon ever had, now has or hereinafter may have against the Village, regarding any matter arising on or before the date of Gannon's execution of this Agreement, whether the claims were made or not made by Gannon.

Said waiver shall include, but shall not be limited to, any and all claims or causes of action, known or unknown, arising out of, or in any way connected with or relating to Gannon's employment with the Village and/or any other interactions with the Village including but not limited to, claims for wages, vacation, payment for accrued unused vacation or sick leave, attorneys' fees, breach of implied or express contract including but not limited to the CBA, or any other cause of action known or unknown, including but not limited to any claims under Title VII of the Civil Rights Act of 1964; the Americans with Disabilities Act ("ADA"); Age Discrimination in Employment Act ("ADEA"); Older Workers Benefit Protection Act ("OWBPA"); Civil Rights Acts of 1866, 1871, and/or 1991; Rehabilitation Act of 1973; 42 U.S.C. §§ 1981, 1983 and/or 1985; Consolidated Omnibus Budget Reconciliation Act ("COBRA"); Employee Retirement Income Security Act ("ERISA"); Health Insurance Portability and Accountability Act ("HIPAA"); Family and Medical Leave Act ("FMLA"); Fair Labor Standards Act ("FLSA"); Families First Coronavirus Response Act; New York State Human Rights Law (Executive Law); New York State Civil Service Law; New York State Correction Law; New York State General Municipal Law; New York State Village Law; New York State Labor Law; New York State Retirement and Social Security Law; New York State Public Officers Law; New York State Civil Rights Law; all New York State Executive Orders; the Westchester County Department of Human Resources (Civil Service) Rules; the Westchester County Human Rights Law; the Village Code; Village/Police Department policies, practices, orders, rules or regulations; the New York State Constitution; the United States Constitution; and all other federal, state, county and local or Village laws, ordinances, regulations, policies or orders. Gannon further agrees not to cause or allow any individual or third party to bring any complaint, charge or other proceeding against the Village before any court, administrative tribunal or in arbitration with respect claims relating to his employment with the Village and/or any other interaction with the Village.

6. Gannon affirms and represents that no charge of discrimination has been filed by Gannon or any representative of Gannon on his behalf against the Village or is currently pending with the United States Equal Employment Opportunity Commission ("EEOC"), the New York State Division of Human Rights or the Westchester County Human Rights Commission, relating to Gannon's employment with the Village.

- 7. Gannon acknowledges and agrees that no claim, action, lawsuit, charge or proceeding with any federal, state or local court or agency, (excluding the New York State Division of Human Rights, the Westchester County Human Rights Commission and/or the EEOC) will be brought or filed by Gannon or any representative of Gannon on his behalf against the Village arising from Gannon's employment with the Village or any other act or omission of the Village that has occurred at any time up to and through the date of his execution of this Agreement.
- 8. In the event Gannon or a representative on his behalf files a charge with the EEOC, the New York State Division of Human Rights and/or the Westchester County Human Rights Commission or in the event of any enforcement or investigatory action undertaken by any of those administrative agencies, Gannon is not prevented or precluded by this Agreement from fully cooperating with the administrative agency or participating fully in the administrative agency's process. Gannon expressly agrees, however, that by signing this Agreement, Gannon is irrevocably waiving and forfeiting any right to recover any monetary or other individual (i.e., equitable) relief as the result of any such EEOC, New York State Division of Human Rights and/or Westchester Human Rights Commission proceeding or any subsequent legal action brought by any of those administrative agencies.
- 9. Gannon further understands and agrees that the Village shall have the right to immediately upon his execution of this Agreement to recruit a permanent replacement for the position of Police Officer.
- 10. This Agreement is entered into in the State of New York and shall be construed and interpreted in accordance with the laws of the State of New York without regard to any state's choice of law or conflicts of law provisions or any state's borrowing statute.
- 11. Any dispute over an alleged breach of this Agreement shall be resolved by an action for breach of this Agreement. The parties agree to the jurisdiction of the Courts of the State of New York to decide such an action and venue shall be in the Supreme Court of the State of New York, Westchester County. The parties waive any right to a jury trial in such action and agree that an action for breach of this Agreement will be decided by the Court.
- 12. Gannon acknowledges that he has been given twenty-one (21) calendar days to review and consider his release of claims under the ADA and OWBPA prior to signing, and that he fully understands and agrees to all of its terms. Gannon acknowledges that after consultation with his chosen attorney(s), he has decided to execute this Agreement without utilizing all of the twenty-one (21) days mentioned herein.
- 13. Gannon may revoke only his release of claims under the ADEA and OWBPA within seven (7) days after he signs this Agreement. Revocation can be made by delivering written notice of revocation to Joseph Cerretani, Village Manager, Village of Ardsley, 507 Ashford Avenue, Ardsley, New York 10502. For this revocation to be

effective, the written notice must be received by Mr. Cerretani's office no later than the close of business on the seventh day after Gannon signs this Agreement, or else Mr. Cerretani's office must be notified by telephone by that day that the written notice has been mailed. Although not required, it is recommended that such notice be sent by certified mail, return receipt requested. If Gannon revokes his release of claims only under the ADEA and/or the OWBPA, he agrees that the Village shall, at its sole discretion, have the option of either enforcing the remaining terms of this Agreement or rescinding this Agreement in its entirety.

- 14. Gannon agrees that by executing this Agreement and not revoking it within seven (7) days of his signing of the Stipulation, the Agreement and all of its parts are binding upon him subject only to execution of the Agreement by the Village.
- 15. Gannon acknowledges that the Village has recommended, and that he has had a full opportunity to discuss this Agreement in detail with his attorney(s) and that he is entering into this Agreement of his own free will.
- 16. This Agreement represents the entire Agreement between and among the parties and supersedes any prior written or oral statements, agreements, memoranda, correspondence, conversations, discussions and/or negotiations held or which have taken place between the parties and/or their agents or representatives with respect to matters covered by this Agreement.
- 17. This Agreement, including this paragraph, may not be altered, amended or modified in any way except by a writing executed by the parties to be bound by such alteration, amendment or modification which writing shall expressly reference the fact that the writing is intended to alter, amend or modify this Agreement. This Agreement, including this paragraph, may not be modified orally.
- 18. The language of all parts of this Agreement must be construed as a whole, according to its fair meaning, and not strictly for or against any party, regardless of who drafted the language. The terms and language of this Agreement are the result of negotiations between the parties to it and there shall be no presumption that any ambiguities in this Agreement should be resolved against any of the parties. Any controversy concerning the construction of this Agreement shall be decided neutrally, in light of conciliatory purposes and without regard to authorship.
- 19. The parties agree that if any of the provisions contained in this Agreement are declared illegal, unenforceable, or ineffective by a legal forum of competent jurisdiction, such provisions shall be deemed severable, such that all other provisions shall remain valid and binding upon all parties. If any provision, or portion of a provision, is found to be illegal, unenforceable, or ineffective by a legal forum of competent jurisdiction, such finding shall not render the rest of this Agreement, or any portion of it, illegal, unenforceable, or ineffective, and the provision found to be illegal, unenforceable, or ineffective shall be changed or interpreted so as to best accomplish the objectives of such provision within the applicable law or court decisions.

- 20. This Agreement may be executed in more than one counterpart, each of which shall be deemed an original, but all of which shall constitute the same instrument, and a fully-executed copy of this Stipulation (including hard copies, facsimile and electronic (PDF) copies) shall have the same force and effect as the original.
- 21. This Agreement shall not establish a precedent with regard to how similar situations involving Gannon or anyone else, including any other PBA bargaining unit member, may be handled in the future.
- 22. This Agreement shall not become final until ratified by duly enacted resolution of the Board of Trustees.

IN WITNESS WHEREOF, and intending to be legally bound hereby, the parties have executed the foregoing Stipulation of Agreement.
