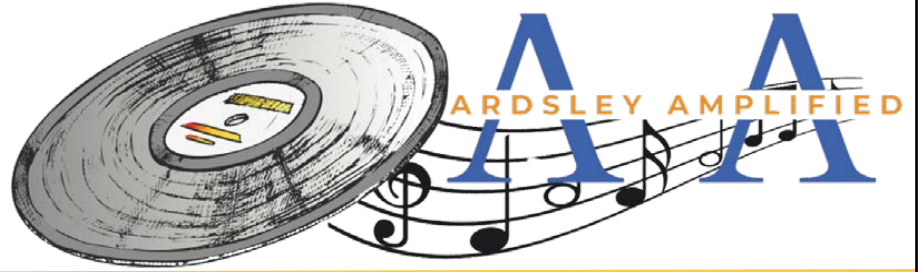
Reflections after studying the French speaking world

- Biking produces zero emissions which can contribute to the overall air quality

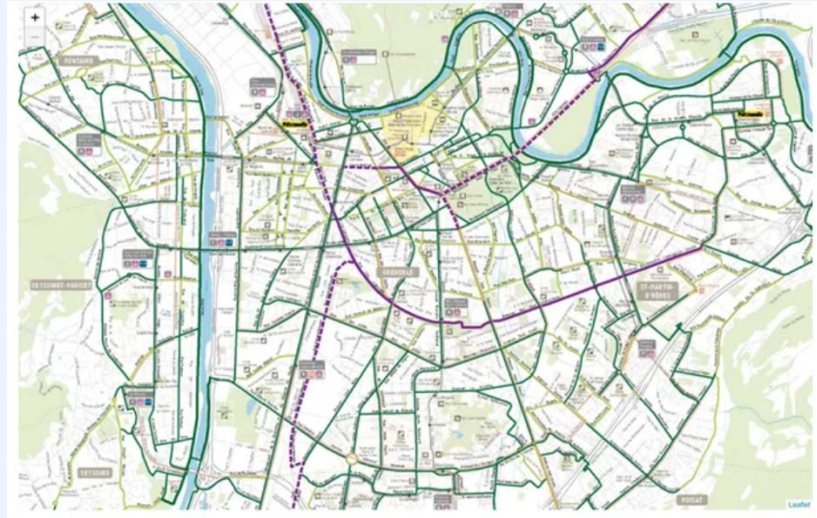


MAP OF BIKE PATHS IN THE FRENCH TOWN OF GRENOBLE

2.1 The Regular Meeting of the Village of Ardsley Board of Trustees was held on Monday, March 18, 2024 at Village Hall, Court Facility, 507 Ashford Avenue, Ardsley, NY 10502. Mayor Kaboolian called to order the Regular Meeting at 8:10 p.m.

3. CONTINUATION OF PUBLIC HEARING In the Matter of the Proposed Development Located at 657 Saw Mill River Road in the Village of Ardsley

3.1 Mayor Kaboolian opened the Public Hearing at 8:11 p.m. in the matter of the Proposed Development Located at 657 Saw Mill River Road in the Village of Ardsley.

- Diana Bunin Kolev Esq. from Law Firm from Del Bello, Donnellan, Weingarten Wise & Wiederkehr, LLP. feels that they are at the point that public hearing should be closed since all comments have been addressed along with the consultants comments. Results have shown that there is no significant environmental impacts and a negative declaration under SEQRA would be appropriate.
- Rick Bohlander reviewed the architectural changes with Board.
- Mayor Kaboolian understands that the applicant would like to close the public hearing tonight but she feels like the applicant has not come back to Board with any compromises regarding the design and size of this building. Closing the public hearing this evening would also trigger a 60 day period for site plan approval.
- Adam Moussa explained that, they are willing to adapt to design changes but reminded the Board that there is an investment behind this. Mr. Moussa will come back with a redesign of the building at the next meeting.
- Planning Consultant, Dave Smith agreed with the Board's approach with

making adjustments to the scale of the building and feels what they have outlined sounds reasonable.

- Building Inspector, Larry Tomasso stated that most of the delays on this project were self imposed and the Village did not holding up the process in this case.
- Diana Bunin Kolev Esq. from Law Firm from Del Bello, Donnellan, Weingarten Wise & Wiederkehr, LLP suggested that 657 Saw Mill River Rd. be discussed at the Board's Work Session on March 25th.
- Mayor Kaboolian explained they will go over the EAF and any new designs that are submitted from the applicant at the next Work Session on March 25th. and continue the Public Hearing to April 1st.
- Trustee Edelstein stated that the Board would like to see something more attractive with the new designs they will be submitting.
- Jodie Reaver, Ardsley resident questioned the number of pumps at this gas station and that the Planning Board referenced a law increasing the pump size was not legal. Ms. Reaver also supports the alternate idea of an Islamic Center over a gas station.
- Building Inspector, Larry Tomasso explained that the Planning Board is not empowered to make that determination.
- Mayor Kaboolian stated that the plan is to have three pumps six nozzles.
- Mayor Kaboolian stated that the plan going forward is to continue discussions and new plan designs on this project at our next Work Session on March 25th and the Public Hearing will continue on April 1st at 8:00 pm. All members of the Board were in agreement with this.

2. MANAGER

- 2.a Village Manager, Joseph L. Cerretani read the following report:

1. GRANT UPDATES: The Village of Ardsley has received a \$135,000 Smart Growth Community Planning and Zoning Grant Award from the New York State

Department of State under the 2023-2024 Environmental Protection Fund. With these funds, the Village will update its zoning code to fully implement its Comprehensive Plan and area focused 'Downtown Ardsley Revitalization Implementation Strategy'. Copies of the Village's Comprehensive Plan and Downtown Ardsley Revitalization Implementation Strategy are available on the Village's website www.ardsleyvillage.com and at Village Hall.

The Village of Ardsley is also proud to announce that a grant has been awarded to the Village in the amount of \$59,384 provided by the New York State Environmental Protection Fund, NYSDEC Hudson River Estuary Program to conduct a Natural Resource Inventory.

A Natural Resource Inventory (NRI) is a systematic and comprehensive assessment of the natural resources within a particular geographic area. The purpose of an NRI is to gather information about the quantity, quality, distribution, and condition of various natural resources, including land, water, air, flora, and fauna. The goal is to provide a baseline understanding of the natural assets in a given area, which can be used for sustainable resource management, conservation, and land-use planning. By compiling and analyzing this information, decision-makers in the Village can make informed decisions about land use planning, resource conservation, and sustainable development. Natural Resource Inventories are valuable tools for balancing human needs with the preservation and responsible management of ecosystems.

Special thanks to Lorraine Kuhn, a dedicated member of the team that spent many hours in the preparation of the grant application.

I am anticipating on an additional update I can present at the next Board meeting regarding additional grant funding for which the Village has applied.

2. DPW PROJECT UPDATE: As mentioned during my last update, the new, permanent transformer has been on site and is being installed. The electrical contractors are in the final stages of the installation and we're working with ConEdison to schedule the final inspections for electrical and gas that will bring the facility online. We're hoping to accomplish this over the coming weeks. This will allow us to get the heat working, which will then allow the other services such as water to come on line. The finishing work will be on hold at this time until the electrical and heat are operational in the facility. Due to the delay, we're now anticipating completion later next month.

3. 2024-2025 BUDGET: The budget process is entering its final stages. I have met with all Village departments and gone through operational and capital items with the department heads. The Tentative Budget will be delivered to the Board later this month and will be posted on the Village website www.ardsleyvillage.com.

8. CORRESPONDENCE

- 8.1 Ardsley Resident, Jodie Reaver submitted the following comments via email on March 4th, 2024 re: 657 Saw Mill River Road proposed development:

Good evening,

I asked questions during tonight’s board meeting about pump numbers and whether there was any discussion at the beginning of the meeting about this topic. During my question I referenced the Planning Board minutes where the law was cited as a reason to hold the gas station applicants to the prior size of two islands with four pumps. There seemed to be confusion about whether or not this was stated during Planning Board minutes. I referenced comments I’d read during a prior board meeting, and for clarification am once again providing references from the Planning Board Minutes.

- May 9, 2022 - The Chair reiterated that applicant is entitled to two islands and four pumps, and no more, under common law.
- October 12, 2022 - The Chair reiterated that it is well established law that one may not increase a non-conforming use

In addition, during the same meeting, I asked the Village Board specifically about comments noted during the September 2022 Planning Board meeting that stated:

- The Chair emphasized that a gas station is a non-conforming use and that without Village approval, one may not increase the intensity of a non-conforming use.

When I asked the Village Board about approval to increase the size it was noted that none had been provided. In addition, the Village Board consistently noted the request for a reduction in pump numbers and referenced this as an example of non-compliance from the applicants.

Hearing Mr. Tomasso's clarifications tonight was helpful, but truthfully his comments seem inconsistent with what the Village Board has stated in the past. I'm left scratching my head wondering why clarification about the pump numbers could not have been provided sooner - both for the applicant and residents.

My request is clarity from an independent legal source regarding pump numbers. I used the term "flip side" tonight as I do believe that the applicants' lawyers have a vested interest in presenting an opinion, and finding case law, that supports their reading of the law. Is there another side/reading to the case law?

Mayor Kaboolian noted traffic and the applicants' study on two vs. three pumps, and that an additional pump, and dispensers, will allow for better traffic flow (not sure if those were the exact words). Another view is that there are three more gas stations in Ardsley and so if someone sees the pumps are full they might keep driving instead of waiting in line to access this gas station. Again, the applicant has a vested interest in their argument, has there been an independent analysis of this argument they are providing?

In closing, I appreciate efforts to make the gas station more attractive, hopefully it works. In my opinion, a reduction in pump numbers is as important as the reduction in building size and the attractiveness of the building. It reduces the overall footprint of the space, and also decreases opportunities for contamination such as there has been in the past.

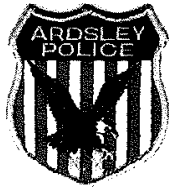


